by amending section 1 (MCL 445.111), as amended by 1998 PA 126.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 1. As used in this act:

(a) "Home solicitation sale" means a sale of goods or services of more than \$25.00 in which the seller or a person acting
for the seller engages in a personal, written, or telephonic,
OR WRITTEN solicitation of the sale, the solicitation is received
by the buyer at a residence of the buyer, and the buyer's agreement or offer to purchase is there given to the seller or a
person acting for the seller. Home solicitation sale includes a
sale arising from a postcard or other written notice delivered to
a buyer's residence that requests that the buyer contact the

Home solicitation sale does not include a 21 (vii) A sale of agricultural or horticultural equipment and 22 machinery that is demonstrated to the consumer by the vendor at 23 the request of either or both of the parties. 24 (b) "Fixed location" means a place of business where the 25 seller or an agent, servant, employee, or solicitor of that

26 seller primarily engages in the sale of goods or services of the 27 same kind as would be sold at the residence of a buyer.

(c) "Business day" means Monday through Friday and does not

3 (F) "WRITTEN SOLICITATION" MEANS A POSTCARD OR OTHER WRITTEN 4 NOTICE DELIVERED TO A BUYER'S RESIDENCE THAT REQUESTS THAT THE ${\bf 5}$ buyer contact the seller or seller's agent by telephone to 6 INQUIRE ABOUT A GOOD OR SERVICE, UNLESS THE POSTCARD OR OTHER 7 WRITTEN NOTICE CONCERNS A PREVIOUS PURCHASE OR ORDER OR SPECIFIES 8 THE PRICE OF THE GOOD OR SERVICE AND ACCURATELY DESCRIBES THE 9 GOOD OR SERVICE.
