HOUSE SUBSTITUTE FOR SENATE BILL NO. 141

A bill to amend 1939 PA 280, entitled "The social welfare act,"

by amending section 57a (MCL 400.57a), as added by 1995 PA 223.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 57a. (1) The family independence agency shall estab-
- 2 lish and administer the family independence program to provide
- 3 assistance to families who are making efforts to achieve
- 4 independence.
- 5 (2) The family independence agency shall administer the
- 6 family independence program to accomplish all of the following:
- 7 (a) Provide financial support to eligible families while
- 8 they pursue self-improvement activities and engage in efforts to
- 9 become financially independent.

- 1 (b) Ensure that recipients who are minor parents live in
- 2 adult-supervised households in order to reduce long-term
- 3 dependency on financial assistance.
- 4 (c) Assist families in determining and overcoming the barri-

- 6 (d) Ensure that families pursue other sources of support
- 7 available to them.
- 8 (3) The family independence agency shall establish income
- 9 and asset levels for eligibility, types of income and assets to
- 10 be considered in making eligibility determinations, payment stan-

- 12 dence assistance group, program budgeting and accounting methods,
- 13 and client reporting requirements to meet the following goals:

- 21 FOOD STAMPS, OR BOTH UNDER MORE THAN 1 NAME. BEGINNING AT THE
- 22 EFFECTIVE DATE OF THE ESTABLISHMENT AND IMPLEMENTATION OF THE
- 23 FINGER IMAGING SYSTEM, AN INDIVIDUAL APPLYING FOR CASH ASSIST-
- 24 ANCE, FOOD STAMPS, OR BOTH MUST PROVIDE THE FAMILY INDEPENDENCE
- 25 AGENCY WITH AN AUTOMATED FINGER IMAGE OR IMAGES AS A CONDITION OF
- 26 ELIGIBILITY. FINGER IMAGING OBTAINED PURSUANT TO THIS SUBSECTION

- 4 MATED FINGER IMAGE SYSTEM THAT, AT A MINIMUM, INCLUDES THE
- 5 FOLLOWING:
- 6 (A) CONFIDENTIALITY OF THE AUTOMATED FINGER IMAGE RECORDS
- 7 TAKEN PURSUANT TO THIS SECTION.
- 8 (B) A SYSTEM FOR ADMINISTRATIVE APPEAL OF A MATTER RELATING
- 9 TO THE TAKING OR VERIFICATION OF AN INDIVIDUAL'S AUTOMATED FINGER
- 10 IMAGE.
- 11 (C) A REQUIREMENT TO EXEMPT CHILDREN FROM PROVIDING THE
- 12 AUTOMATED FINGER IMAGE UNLESS THERE IS A REASONABLE SUSPICION
- 13 THAT THE FAMILY GROUP IS COMMITTING FRAUD. [FOR THE PURPOSE OF THIS SUBDIVISION, "FAMILY GROUP" MEANS A FAMILY AND ALL THOSE INDIVIDUALS LIVING WITH A FAMILY WHO APPLY FOR OR RECEIVE CASH ASSISTANCE, FOOD STAMPS, OR BOTH.]
- 14 (D) A REQUIREMENT TO EXEMPT INDIVIDUALS FROM WHOM THE AUTO-
- 15 MATED FINGER IMAGE TECHNOLOGY IS UNABLE TO OBTAIN AN ACCURATE
- 16 FINGER IMAGE.
- 17 [(E) A REQUIREMENT TO EXEMPT PATIENTS PLACED IN NURSING HOMES
- 18 FROM PROVIDING THE AUTOMATED FINGER IMAGE.
- 19 (F) IN ADDITION TO THE POPULATION GROUPS NAMED IN SUBDIVISIONS
- 20 (C), (D), AND (E), AUTHORITY TO EXEMPT CERTAIN OTHER POPULATION
- 21 GROUPS FROM PROVIDING THE AUTOMATED FINGER IMAGE INCLUDING, BUT NOT LIMITED TO, HOMEBOUND RECIPIENTS.]
- 22 (6) THE FAMILY INDEPENDENCE AGENCY SHALL REMOVE AN
- 23 INDIVIDUAL'S FINGER IMAGE FROM THE DEPARTMENT'S FILE IF THE INDI-
- 24 VIDUAL HAS NOT RECEIVED BENEFITS OR ASSISTANCE FROM THE FAMILY
- 25 INDEPENDENCE AGENCY WITHIN THE PREVIOUS [12 MONTHS].
- 26 (7) THE FAMILY INDEPENDENCE AGENCY MAY NEGOTIATE AND ENTER
- 27 INTO A COMPACT OR RECIPROCAL AGREEMENT WITH ANOTHER STATE

- 1 DEPARTMENT, THE FEDERAL GOVERNMENT, AN AGENCY OF THE FEDERAL
- 2 GOVERNMENT, OR AN AGENCY OF ANOTHER STATE FOR THE PURPOSE OF

- 11 RATE AND COMPLETE.
- 12 (B) EFFECTIVE SOFTWARE AND HARDWARE DESIGNS HAVE BEEN INSTI-
- 13 TUTED WITH SECURITY FEATURES TO PREVENT UNAUTHORIZED ACCESS TO
- 14 RECORDS.
- 15 (C) ACCESS TO RECORD INFORMATION IS RESTRICTED TO AUTHORIZED
- 16 PERSONNEL.
- 17 (D) SYSTEM AND OPERATIONAL PROGRAMS ARE USED THAT WILL PRO-
- 18 HIBIT INQUIRY, RECORD UPDATES, OR DESTRUCTION OF RECORDS FROM A
- 19 TERMINAL OTHER THAN AUTOMATED FINGER IMAGING SYSTEM TERMINALS
- 20 THAT ARE DESIGNATED TO PERMIT INQUIRY, RECORD UPDATES, OR
- 21 DESTRUCTION OF RECORDS.
- 22 (E) SYSTEM AND OPERATIONAL PROGRAMS ARE USED TO DETECT AND
- 23 REPORT ALL UNAUTHORIZED ATTEMPTS TO PENETRATE AN AUTOMATED FINGER
- 24 IMAGING SYSTEM, PROGRAM, OR FILE.
- 25 (9) BEGINNING DECEMBER 31 OF THE FIRST YEAR THE AUTOMATED
- 26 FINGER IMAGING SYSTEM HAS BEEN FULLY IMPLEMENTED, THE FAMILY
- 27 INDEPENDENCE AGENCY SHALL COMPILE AND REPORT ANNUALLY TO THE

- 14 (10) EXCEPT AS NECESSARY TO CARRY OUT A COMPACT OR AGREEMENT
- 15 UNDER SUBSECTION (7) OR UNLESS OTHERWISE REQUIRED BY LAW, THE
- 16 FAMILY INDEPENDENCE AGENCY SHALL NOT SELL, TRANSFER, OR RELEASE
- 17 INFORMATION IDENTIFYING AN INDIVIDUAL NAMED IN THE AUTOMATED
- 18 FINGER IMAGING SYSTEM RECORD TO A THIRD PERSON, INCLUDING, BUT
- 19 NOT LIMITED TO, ANOTHER STATE DEPARTMENT OR AGENCY.
- 20 (11) A PERSON SHALL NOT DISCLOSE INFORMATION FROM THE AUTO-
- 21 MATED FINGER IMAGING SYSTEM RECORD IN A MANNER THAT IS NOT AUTHO-
- 22 RIZED BY LAW OR RULE. A VIOLATION OF THIS SUBSECTION IS A MISDE-
- 23 MEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 93 DAYS OR A
- 24 FINE OF NOT MORE THAN \$500.00, OR BOTH.
- 25 (12) AT THE TIME AN INDIVIDUAL APPLIES FOR CASH ASSISTANCE,
- 26 FOOD STAMPS, OR BOTH, THE FAMILY INDEPENDENCE AGENCY SHALL INFORM
- 27 THE INDIVIDUAL OF ALL OF THE FOLLOWING:
