- 5 (2) The family independence agency shall administer the
- 6 family independence program to accomplish all of the following:
- 7 (a) Provide financial support to eligible families while
- 8 they pursue self-improvement activities and engage in efforts to
- 9 become financially independent.

- 13 VIDING THE AUTOMATED FINGER IMAGE INCLUDING, BUT NOT LIMITED TO,
- 14 SENIOR CITIZENS, CHILDREN, HOMEBOUND RECIPIENTS, OR PATIENTS
- 15 PLACED IN NURSING HOMES.
- 16 (6) THE FAMILY INDEPENDENCE AGENCY SHALL REMOVE AN
- 17 INDIVIDUAL'S FINGER IMAGE FROM THE DEPARTMENT'S FILE IF THE INDI-
- 18 VIDUAL HAS NOT RECEIVED BENEFITS OR ASSISTANCE FROM THE FAMILY
- 19 INDEPENDENCE AGENCY WITHIN THE PREVIOUS 3 YEARS.
- 20 (7) THE FAMILY INDEPENDENCE AGENCY MAY NEGOTIATE AND ENTER
- 21 INTO A COMPACT OR RECIPROCAL AGREEMENT WITH THE FEDERAL GOVERN-
- 22 MENT, AN AGENCY OF THE FEDERAL GOVERNMENT, OR AN AGENCY OF
- 23 ANOTHER STATE FOR THE PURPOSE OF IMPLEMENTING AND ADMINISTERING
- 24 THE FINGER IMAGING PROVISIONS OF THIS SECTION AS LONG AS THE COM-
