- 1 Sec. 203. (1) The Michigan register fund is created in the
- 2 state treasury and shall be administered by the council. The
- 3 fund shall be expended only as provided in this section.
- 4 (2) The money received from the sale of the Michigan regis-
- 5 ter, along with those amounts paid by state agencies pursuant to
- 6 section 57 of the administrative procedures act of 1969, Act
