Sec. 1. This act shall be known and may be cited as the
 "Michigan tobacco settlement trust fund act".

Sec. 2. As used in this act:

4 (a) "Tobacco settlement revenue" means money received by
5 this state that is attributable to the master settlement agree6 ment incorporated into a consent decree and final judgment
7 entered into on December 7, 1998 in <u>Kelly Ex Rel. Michigan</u> v
8 <u>Philip Morris Incorporated, et al.</u>, Ingham county circuit court,
9 docket no. 96-84281CZ.

10 (b) "Tobacco settlement trust fund" means the Michigan11 tobacco settlement trust fund established in section 3.

Sec. 3. (1) The Michigan tobacco settlement trust fund is
 established in the department of treasury. The trust fund shall
 consist only of interest and earnings from trust fund invest ments, donations of money made to the trust fund from any source,
 and the following percentages of tobacco settlement revenue:

6 (a) Seventy percent of the tobacco settlement revenue7 received in fiscal year 1999-2000.

8 (b) Fifty percent of the tobacco settlement revenue received9 in fiscal year 2000-2001.

10 (c) Twenty-five percent of the tobacco settlement revenue 11 received in fiscal year 2001-2002 and each subsequent fiscal 12 year.

13 (2) The state treasurer shall direct the investment of the14 tobacco settlement trust fund.

15 Sec. 4. The legislature shall authorize the expenditure of 16 tobacco settlement trust fund revenues through an appropriation 17 act.
