SEC. 285. (1) A PERSON SHALL NOT OBTAIN OR ATTEMPT TO
 OBTAIN PERSONAL IDENTITY INFORMATION OF ANOTHER PERSON WITH THE
 INTENT TO USE THAT INFORMATION TO COMMIT AN ILLEGAL ACT.

5 PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 4 YEARS OR A FINE OF
