- 3 (A) MISREPRESENT HIS OR HER IDENTITY TO A PEACE OFFICER WHO
- 4 HAS LAWFULLY REQUESTED INFORMATION REGARDING HIS OR HER IDENTITY
- 5 UNDER CIRCUMSTANCES IN WHICH THE INDIVIDUAL IS REQUIRED TO
- 6 PRODUCE THAT INFORMATION.
- 7 (B) FALSELY INFORM A PEACE OFFICER WHO LAWFULLY REQUESTS TO
- 8 SEE MATERIAL IDENTIFYING THAT INDIVIDUAL THAT HE OR SHE DOES NOT
- 9 HAVE THAT MATERIAL IN HIS OR HER POSSESSION UNDER CIRCUMSTANCES
- 10 IN WHICH THE INDIVIDUAL IS REQUIRED TO PRODUCE THAT MATERIAL.
