

# HOUSE BILL No. 4345

February 25, 1999, Introduced by Reps. Howell, Julian, Patterson, Jellema, Caul, Pappageorge, Pumford, Ehardt, Bishop, Tabor, Van Woerkom, Bradstreet, Voorhees, Gosselin, Garcia, Bovin, DeVuyst and Raczkowski and referred to the Committee on Criminal Law and Corrections.

A bill to amend 1927 PA 175, entitled  
"The code of criminal procedure,"  
by amending section 16g of chapter XVII (MCL 777.16g), as added  
by 1998 PA 317.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:
