SEC. 39D. (1) FOR TAX YEARS THAT BEGIN AFTER DECEMBER 31,
 1998, A QUALIFIED TAXPAYER MAY CLAIM A CREDIT AGAINST THE TAX
 IMPOSED BY THIS ACT EQUAL TO THE TOTAL OF THE FOLLOWING AMOUNTS:
 (A) IF THE TAXPAYER PAYS AT LEAST THE MINIMUM WAGE TO AN
 ELIGIBLE EMPLOYEE, 50% OF THE WAGES PAID TO THAT ELIGIBLE
 EMPLOYEE FOR THE TERM OF EMPLOYMENT AGREED UPON WHEN THE ELIGIBLE
 EMPLOYEE WAS HIRED.

8 (B) IF THE TAXPAYER PAYS LESS THAN THE MINIMUM WAGE TO AN9 ELIGIBLE EMPLOYEE, 10% OF THE WAGES PAID TO THAT ELIGIBLE
