- 12 (B) MEET NOT LESS THAN 4 TIMES PER YEAR AT A PLACE AND TIME
- 13 SPECIFIED BY THE CHAIRPERSON.
- 14 (C) KEEP A RECORD OF THE PROCEEDINGS AND ACTIVITIES OF THE
- **15** COMMITTEE.
- 16 (D) PROVIDE RECOMMENDATIONS TO PUBLIC SAFETY ANSWERING
- 17 POINTS AND SECONDARY PUBLIC SAFETY ANSWERING POINTS ON STATEWIDE
- 18 TECHNICAL AND OPERATIONAL STANDARDS FOR PSAPS AND SECONDARY
- 19 PSAPS.
- 20 (E) PROVIDE RECOMMENDATIONS TO PUBLIC AGENCIES CONCERNING
- 21 MODEL SYSTEMS TO BE CONSIDERED IN PREPARING A 9-1-1 SERVICE
- **22** PLAN.
- 23 (F) PERFORM OTHER DUTIES AS NECESSARY TO PROMOTE SUCCESSFUL
- **24** DEVELOPMENT, IMPLEMENTATION, AND OPERATION OF 9-1-1 SYSTEMS
- 25 ACROSS THE STATE.
- 26 (2) THE DEPARTMENT OF STATE POLICE AND THE PUBLIC SERVICE
- 27 COMMISSION SHALL PROVIDE STAFF ASSISTANCE TO THE COMMITTEE AS
