## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 17401. (1) As used in this part:
- 2 (a) "Optometrist" means an individual licensed under this
- 3 article to engage in the practice of optometry.
- 4 (b) "Practice of optometry" means 1 or more of the follow-
- 5 ing, but does not include the performance of invasive
- 6 procedures:
- 7 (i) The examination of the human eye to ascertain the pres-
- 8 ence of DIAGNOSE defects or abnormal conditions which THAT may
- 9 be corrected, remedied, or relieved, or the effects of which may

- 1 be corrected, remedied, or relieved by the use of lenses, prisms,
- 2 or other mechanical devices.
- 3 (ii) The employment of objective or subjective physical
- 4 means to determine the accommodative or refractive conditions or
- 5 the range of powers of vision or muscular equilibrium of the
- 6 human eye.
- 7 (iii) The adaptation or the adjustment of the lenses or
- 8 prisms or the use of therapeutic pharmaceutical agents to cor-
- 9 rect, remedy, or relieve a defect or abnormal condition or to
- 10 correct, remedy, or relieve the effect of a defect or abnormal
- 11 condition of the human eye.
- 12 (iv) The examination of the human eye for contact lenses and
- 13 the fitting or insertion of contact lenses to the human eye.
- 14 (v) The employment of objective or subjective means, includ-
- 15 ing diagnostic pharmaceutical agents by an optometrist who meets
- 16 the requirements of section 17412, for the examination of the
- 17 human eye for the purpose of ascertaining DIAGNOSING a depar-
- 18 ture from the normal, measuring of powers of vision, and adapting
- 19 lenses for the aid thereof.
- 21 (i) The following commercially prepared topical anesthetic:

- 7 HUMAN EYE OR TO CORRECT, REMEDY, OR RELIEVE THE EFFECTS OF A
- 8 DEFECT OR ABNORMAL CONDITION OF THE HUMAN EYE.
- 9 (C) "DIAGNOSTIC PHARMACEUTICAL AGENT" MEANS A TOPICALLY
- 10 ADMINISTERED PRESCRIPTION DRUG OR OTHER TOPICALLY ADMINISTERED
- 11 DRUG USED FOR THE PURPOSE OF DIAGNOSING THE PRESENCE OR ABSENCE
- 12 OF DEFECTS OR ABNORMAL CONDITIONS OF THE HUMAN EYE OR THE EFFECTS
- 13 OF DEFECTS OR ABNORMAL CONDITIONS OF THE HUMAN EYE.
- 14 (d) "Therapeutic pharmaceutical agent" means 1 or more of
- 15 the following:
- 16 (i) A topically administered prescription drug or other top-
- 17 ically administered drug used for the purpose of correcting, rem-
- 18 edying, or relieving a defect or abnormal condition of the ante-
- 19 rior segment of the human eye or for the purpose of correcting,
- 20 remedying, or relieving the effects of a defect or abnormal con-
- 21 dition of the anterior segment of the human eye.
- 22 (ii) A topically administered antiglaucoma drug.
- (e) "Drug" means that term as defined in section 17703, but
- 24 does not include a controlled substance as defined in section
- 25 7104 or a prescription drug.

- 1 (f) "Prescription drug" means that term as defined in
- 2 section 17708, but does not include a controlled substance as
- 3 defined in section 7104.
- 4 (g) "Physician" means that term as defined in section 17001
- **5** or 17501.
- 6 (h) "Invasive procedures" means all of the following:
- 7 (i) The use of lasers other than for observation.
- 8 (ii) The use of ionizing radiation.
- 9 (iii) The use of therapeutic ultrasound.
- 10 (iv) The administration of medication by injection.
- 11 (v) Procedures that include an incision.
- 12 (2) In addition to the definitions in this part, article 1
- 13 contains general definitions and principles of construction
- 14 applicable to all articles in this code and part 161 contains
- 15 definitions applicable to this part.
