

HOUSE BILL No. 4908

September 29, 1999, Introduced by Rep. Stallworth and referred to the Committee on Regulatory Reform.

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"

(MCL 436.1101 to 436.2303) by adding section 545.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 545. (1) THE COMMISSION SHALL PROMULGATE A RULE PURSU-
- 2 ANT TO THE ADMINISTRATIVE PROCEDURES ACT OF 1969, 1969 PA 306,
- 3 MCL 24.201 TO 24.328, TO ESTABLISH A PROGRAM FOR THE ISSUANCE OF
- 4 A PERMIT TO A LICENSEE OFFERING SPACE ON THE LICENSED PREMISES
- 5 FOR THE ADVERTISING AND PROMOTING OF ALCOHOLIC LIQUOR. THE PRO-
- 6 GRAM SHALL INCLUDE THE ESTABLISHMENT OF THE FOLLOWING:
- 7 (A) A SCHEDULE FOR THE ALLOCATION OF SPACE.
- 8 (B) A PERIODIC LEASING SCHEDULE.
- 9 (C) PERMITTING FEES BASED UPON THE ALLOCATION SCHEDULE,

10 SUBJECT TO SUBSECTION (2).

- 1 (2) IN THE CASE OF ADVERTISING AND PROMOTION SPACE OFFERED
- 2 BY THE LICENSEE LOCATED ON A BILLBOARD OR OTHER SIGN ATTACHED TO
- 3 THE EXTERIOR OF THE LICENSED PREMISES, THE FEE SHALL BE NOT LESS
- 4 THAN 10% OF THE PERIODIC GROSS LEASE RATE.
- 5 (3) PERMITTING FEES AND ADMINISTRATIVE FINES SHALL BE DEPOS-
- 6 ITED INTO THE GENERAL FUND AND APPROPRIATED TO THE COMMISSION IN
- 7 AN AMOUNT SUFFICIENT TO COVER, BUT NOT TO EXCEED, THE COSTS OF
- 8 ADMINISTRATION AND ENFORCEMENT OF THE PROGRAM CREATED UNDER SUB-
- 9 SECTION (1). FUNDS IN EXCESS OF THE AMOUNT NEEDED TO ADMINISTER
- 10 AND ENFORCE THE PROGRAM CREATED UNDER SUBSECTION (1) SHALL BE
- 11 APPROPRIATED TO THE OFFICE OF DRUG CONTROL POLICY IN THE DEPART-
- 12 MENT OF COMMUNITY HEALTH.
- 13 (4) NOTWITHSTANDING SECTION 903, A VIOLATION OF THE PROGRAM
- 14 ESTABLISHED UNDER THIS SECTION IS SUBJECT TO AN ADMINISTRATIVE
- 15 FINE OF NOT LESS THAN \$500.00 FOR EACH MONTH AN ADVERTISING OR
- 16 PROMOTION LOCATION IS IN USE BUT NOT PERMITTED.
