November 30, 1999, Introduced by Reps. DeWeese, Sheltroun, Bovin, Schauer, Shackleton, Mortimer, Voorhees, Tabor, Green, Howell, Julian, Koetje, Ehardt, Garcia, Martinez and DeHart and referred to the Committee on Appropriations.

A bill to amend 1943 PA 240, entitled "State employees' retirement act," (MCL 38.1 to 38.69) by adding section 20i.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 20I. (1) EFFECTIVE OCTOBER 1, 2000, THE MONTHLY
2 RETIREMENT ALLOWANCE PAYABLE TO A RETIRANT OR RETIREMENT ALLOW-
3 ANCE BENEFICIARY WHOSE RETIREMENT ALLOWANCE EFFECTIVE DATE WAS
4 BEFORE OCTOBER 1, 1996, AS RECALCULATED PURSUANT TO SECTION 19(2)
5 AND 20(6), IS SUPPLEMENTED AS FOLLOWS:

17 (2) THE RECALCULATED RETIREMENT ALLOWANCE SHALL BE THE BASIS
 18 ON WHICH FUTURE ADJUSTMENTS TO THE ALLOWANCE ARE CALCULATED.

19 (3) THE SUPPLEMENT PROVIDED BY THIS SECTION SHALL BE CALCULATED PURSUANT TO SUBSECTION (1), SHALL BE BASED ON THE AMOUNT OF
 20 RETIREMENT ALLOWANCE THAT WOULD HAVE BEEN PAID WITHOUT APPLICATION OF SECTION 20(2), AND SHALL BE PAID BY JANUARY 1, 2001. THE
 21 RETIREMENT ALLOWANCE OF A RETIRANT WHO DIES BEFORE JANUARY 1,
 22 2001 AND WHO HAS NOT NOMINATED A RETIREMENT ALLOWANCE BENEFICIARY
 23 PURSUANT TO SECTION 31 SHALL NOT BE SUPPLEMENTED PURSUANT TO THIS
 24 SECTION.
