A bill to amend 1978 PA 368, entitled "Public health code,"

by amending sections 17766c and 17770 (MCL 333.17766c and 333.17770), section 17766c as added by 1994 PA 38, and by adding section 17766d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 17766c. (1) A person shall not possess more than -10-
- 2 2 grams of ephedrine, A SALT OF EPHEDRINE, AN ISOMER OF EPHED-
- 3 RINE, OR A SALT OF AN ISOMER OF EPHEDRINE, alone OR IN
- 4 COMBINATION, or in a SUBSTANCE OR mixture CONTAINING EPHEDRINE,
- 5 A SALT OF EPHEDRINE, AN ISOMER OF EPHEDRINE, OR A SALT OF AN
- 6 ISOMER OF EPHEDRINE.
- 7 (2) A person who violates this section is guilty of a felony
- 8 punishable by imprisonment for not more than 2 years or a fine of
- **9** not more than \$2,000.00, or both.

- 24 (4) THE BOARD MAY REMOVE THE EXEMPTION OF A PRODUCT EXEMPTED
- 25 UNDER OR LISTED IN SUBSECTION (3) IF THE BOARD DETERMINES AFTER
- 26 NOTICE AND A HEARING THAT THE PRODUCT DOES NOT MEET THE CRITERIA
- **27** OF SUBSECTION (3)(A)(i) AND (ii).

- 1 (5) IN DETERMINING WHETHER TO EXEMPT A PRODUCT UNDER
- 2 SUBSECTION (3), THE BOARD SHALL CONSIDER ALL OF THE FOLLOWING:
- 3 (A) THE MANNER OF PACKAGING THE PRODUCT, INCLUDING THE PACK-
- 4 AGE SIZE.
- 5 (B) THE PRODUCT'S NAME AND LABELING.
- 6 (C) THE MANNER OF DISTRIBUTING, ADVERTISING, AND PROMOTING
- 7 THE PRODUCT.
- 8 (D) THE DURATION, SCOPE, AND SIGNIFICANCE OF ABUSE OF THE
- 9 PRODUCT.
- 10 (E) THE NEED TO PROVIDE MEDICALLY IMPORTANT THERAPIES CON-
- 11 TAINING EPHEDRINE, ITS SALTS OR ISOMERS, OR SALTS OF ITS ISOMERS
- 12 TO THE PUBLIC ON AN OVER-THE-COUNTER BASIS FOR INDICATIONS
- 13 APPROVED BY THE FOOD AND DRUG ADMINISTRATION.
- 14 (F) OTHER FACTS OR CONSIDERATIONS THE BOARD DETERMINES ARE
- 15 RELEVANT TO AND CONSISTENT WITH THE PUBLIC HEALTH AND SAFETY.
- 16 (6) NOT LESS THAN ONCE A YEAR, THE BOARD SHALL PUBLISH A
- 17 LIST OF PRODUCTS EXEMPTED UNDER SUBSECTION (3)(A) OR FOR WHICH
- 18 THE BOARD HAS REMOVED AN EXEMPTION UNDER SUBSECTION (4).
