## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 40. (1) A CANDIDATE COMMITTEE OR BALLOT QUESTION COM-
- 2 MITTEE THAT HOLDS OR SPONSORS A FUND RAISING EVENT OR IS PRESENT
- 3 AT ANY OTHER EVENT AT WHICH EVENT POLITICAL MERCHANDISE IS SOLD
- 4 TO BENEFIT THE COMMITTEE IS SUBJECT TO THIS SECTION. ANY OTHER
- 5 COMMITTEE THAT HOLDS OR SPONSORS A FUND RAISING EVENT OR IS
- 6 PRESENT AT ANY OTHER EVENT AT WHICH EVENT POLITICAL MERCHANDISE
- 7 IS SOLD TO BENEFIT A CANDIDATE COMMITTEE OR BALLOT QUESTION COM-
- 8 MITTEE IS SUBJECT TO THIS SECTION. THE PROVISIONS OF THIS SEC-
- 9 TION ARE IN ADDITION TO ALL OTHER PROVISIONS OF THIS ACT

- 24 (v) A STATEMENT INDICATING THAT IT IS A VIOLATION OF
- 25 MICHIGAN LAW TO SPEND MORE THAN \$20.00 PURCHASING MERCHANDISE AT
- 26 THE EVENT, UNLESS THE NAME, ADDRESS, AND OCCUPATION, IF

- 1 APPLICABLE, OF THE PURCHASER IS RECORDED AS REQUIRED BY THIS
- **2** ACT.
- 3 (3) THE COMMITTEE SHALL ENSURE THAT A SIGN POSTED PURSUANT
- 4 TO THIS SECTION REMAINS POSTED DURING THE ENTIRE TIME THAT POLIT-
- 5 ICAL MERCHANDISE IS OFFERED FOR SALE AT THE EVENT.
- 6 (4) THIS SECTION DOES NOT APPLY TO ACTIVITIES REGULATED BY
- 7 THE TRAXLER-MCCAULEY-LAW-BOWMAN BINGO ACT, 1972 PA 382, MCL
