THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 411R. (1) EXCEPT AS PROVIDED IN SUBSECTION (2), AN
- 2 INDIVIDUAL WHO COMMITS OR ATTEMPTS TO COMMIT A VIOLENT FELONY IN
- 3 WHICH THE VICTIM IS A SENIOR CITIZEN IS GUILTY OF A FELONY PUN-
- 4 ISHABLE BY IMPRISONMENT FOR NOT MORE THAN 3 YEARS.
- 5 (2) AN INDIVIDUAL WHO COMMITS OR ATTEMPTS TO COMMIT A FELONY
- 6 DESCRIBED IN SUBSECTION (1) IN THE SENIOR CITIZEN'S HOME IS
- 7 GUILTY OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 5
- 8 YEARS.
- 9 (3) IT IS NOT A DEFENSE TO A CONVICTION UNDER THIS SECTION
- 10 THAT THE DEFENDANT DID NOT KNOW THE VICTIM WAS A SENIOR CITIZEN.
