

SENATE BILL NO. 736

September 23, 1999, Introduced by Senators JOHNSON, MC COTTER, HAMMERSTROM, ROGERS, SCHUETTE, EMMONS, MC MANUS, GOSCHKA, STILLE, BENNETT, GAST, SHUGARS, GOUGEON, BULLARD, SIKKEMA, NORTH, STEIL, DINGELL, PETERS, KOIVISTO, DE BEAUSSAERT, LELAND, MILLER and A. SMITH and referred to the Committee on Judiciary.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
