A bill to amend 1945 PA 327, entitled "Aeronautics code of the state of Michigan," by amending sections 9 and 151 (MCL 259.9 and 259.151), as amended by 1996 PA 370.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 9. (1) "Airport" means any location, either on land or
 water, that is used for the landing or take-off of aircraft, and
 includes the buildings and facilities, if any, on that location.

Sec. 151. (1) The commission may create and establish a state plan for approach protection areas surrounding airports, landing fields, and other aeronautical facilities, by establishing standards <u>of height</u> to which any structure or obstruction, <u>of any nature</u>, whether <u>object of nature</u> NATURAL or <u>man-created</u> HUMAN-MADE, may be erected or maintained within a distance from the boundaries of any airport, landing field or other aeronautical facility necessary for the safe landing, take-off or other use of such facilities by aircraft operating within this state.

(2) THE AIRPORT MANAGER OF AN AIRPORT LICENSED UNDER THIS
ACT SHALL PROMPTLY FILE ALL OF THE FOLLOWING WITH THE ZONING
BOARD, ZONING COMMISSION, OR OTHER COMMISSION APPOINTED TO RECOMMEND ZONING REGULATIONS, IF ANY, OF ANY TOWNSHIP, COUNTY, VILLAGE, OR CITY THAT IS LOCATED IN WHOLE OR IN PART WITHIN THE
APPROACH PROTECTION AREA:

17 (A) A COPY OF THE AIRPORT APPROACH PLAN FOR THE AIRPORT, IF18 ANY.

19 (B) A COPY OF THE AIRPORT LAYOUT PLAN FOR THE AIRPORT, IF20 ANY.

(C) A REGISTRATION OF THE AIRPORT'S NAME AND MAILING ADDRESS
FOR THE PURPOSES OF RECEIPT OF NOTICE UNDER SECTION 4 OF THE CITY
AND VILLAGE ZONING ACT, 1921 PA 207, MCL 125.584, SECTION 9 OF
THE COUNTY ZONING ACT, 1943 PA 183, MCL 125.209, OR SECTION 9 OF
THE TOWNSHIP ZONING ACT, 1943 PA 184, MCL 125.279.
