## **SENATE BILL No. 813**

## October 14, 1999, Introduced by Senators SIKKEMA, SCHUETTE and MC COTTER and referred to the Committee on Reapportionment.

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 302 (MCL 600.302), as amended by 1993 PA 190.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 302. (1) For the election of judges, the state is
 divided into 4 judicial districts. Each district is entitled to
 elect 7 judges. The districts are constituted and numbered as
 follows:

5 District 1 consists of the counties of Wayne, Monroe, and6 Lenawee.

7 District 2 consists of the counties of Genesee, Shiawassee,8 Oakland, and Macomb.

9 District 3 consists of the counties of Berrien, Cass,10 St. Joseph, Branch, Hillsdale, Washtenaw, Livingston, Jackson,

Calhoun, Kalamazoo, Van Buren, Allegan, Barry, Kent, Ottawa, and
 Muskegon.

Jistrict 4 consists of the counties of Eaton, Ingham, Ionia,
Montcalm, Clinton, Gratiot, Saginaw, Tuscola, Lapeer, St. Clair,
Sanilac, Huron, Bay, Midland, Isabella, Mecosta, Newaygo, Oceana,
Mason, Lake, Osceola, Clare, Gladwin, Arenac, Iosco, Ogemaw,
Roscommon, Missaukee, Wexford, Manistee, Benzie, Grand Traverse,
Leelanau, Kalkaska, Crawford, Oscoda, Alcona, Alpena,
Montmorency, Otsego, Antrim, Emmet, Charlevoix, Cheboygan,
Presque Isle, Mackinac, Chippewa, Luce, Schoolcraft, Alger,
Delta, Menominee, Dickinson, Marquette, Iron, Baraga, Houghton,
Keweenaw, Gogebic, and Ontonagon.

13 (2) ANY CHANGE IN THE JUDICIAL DISTRICT'S BOUNDARIES SHALL 14 BE DETERMINED BY USING POPULATION DATA FROM THE UNITED STATES 15 BUREAU OF THE CENSUS IDENTICAL TO THOSE FROM THE ACTUAL ENUMERA-16 TION CONDUCTED BY THE UNITED STATES BUREAU OF THE CENSUS FOR THE **17** APPORTIONMENT OF THE REPRESENTATIVES OF THE UNITED STATES HOUSE 18 OF REPRESENTATIVES IN THE UNITED STATES DECENNIAL CENSUS. 19 DISTRICT BOUNDARIES SHALL NOT BE DETERMINED BY USING CENSUS 20 BUREAU POPULATION COUNTS DERIVED FROM ANY OTHER MEANS, INCLUDING, 21 BUT NOT LIMITED TO, THE USE OF STATISTICAL SAMPLING TO ADD OR **22** SUBTRACT POPULATION BY INFERENCE. OTHER GOVERNMENTAL CENSUS FIG-23 URES OF TOTAL POPULATION MAY BE USED IF TAKEN SUBSEQUENT TO THE 24 LAST DECENNIAL UNITED STATES CENSUS AND THE UNITED STATES CENSUS **25** FIGURES ARE NOT ADEOUATE FOR THE PURPOSES OF THIS ACT. A CON-26 TRACT MAY BE ENTERED INTO WITH THE UNITED STATES CENSUS BUREAU OR 27 ANY OTHER GOVERNMENTAL UNIT TO MAKE ANY SPECIAL CENSUS IF THE
