A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," (MCL 324.101 to 324.90106) by adding section 3112c.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 3112C. (1) THE DEPARTMENT SHALL COMPILE AND MAINTAIN A
- 2 LIST OF OCCURRENCES OF DISCHARGES OF UNTREATED OR PARTIALLY
- 3 TREATED SEWAGE FROM SEWER SYSTEMS INTO THE WATERS OF THE STATE.
- 4 THIS LIST SHALL BE MADE AVAILABLE ON THE DEPARTMENT'S WEBSITE ON
- 5 AN ONGOING BASIS. IN ADDITION, THE DEPARTMENT SHALL ANNUALLY
- 6 PUBLISH THIS LIST AND MAKE IT AVAILABLE TO THE GENERAL PUBLIC.
- 7 THE LIST SHALL INCLUDE ALL OF THE FOLLOWING:
- 8 (A) THE ENTITY RESPONSIBLE FOR THE DISCHARGE.
- 9 (B) THE WATERS OR LAND AREA, OR BOTH, RECEIVING THE

10 DISCHARGE.

- 1 (C) THE VOLUME AND QUALITY OF THE DISCHARGE.
- 2 (D) THE TIME THE DISCHARGE BEGAN AND ENDED.

- 4 ADDRESS THE DISCHARGE.

- 7 (G) ANY OTHER INFORMATION THAT THE DEPARTMENT CONSIDERS
- 8 RELEVANT.
- 9 (2) AS USED IN THIS SECTION:
- 10 (A) "PARTIALLY TREATED SEWAGE" MEANS ANY SEWAGE, SEWAGE AND
- 11 STORM WATER, OR SEWAGE AND WASTEWATER, FROM DOMESTIC OR INDUS-
- 12 TRIAL SOURCES THAT IS NOT TREATED TO NATIONAL SECONDARY TREATMENT
- 13 STANDARDS FOR WASTEWATER OR THAT IS TREATED TO A LEVEL LESS THAN
- 14 THAT REQUIRED BY A NATIONAL POLLUTANT DISCHARGE ELIMINATION
- 15 SYSTEM PERMIT.
- 16 (B) "SEWER SYSTEM" MEANS A SEWER SYSTEM DESIGNED AND USED TO
- 17 CONVEY SANITARY SEWAGE OR STORM WATER, OR BOTH.
