A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 506b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 506B. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
- 2 ACT, AN INDIVIDUAL CONVICTED OF COMMITTING OR ATTEMPTING TO
- 3 COMMIT A VIOLATION OF THIS ACT IN WHICH THE VICTIM IS A VULNERA-
- 4 BLE ADULT, IS 65 YEARS OF AGE OR OLDER, OR IS LESS THAN 18 YEARS
- 5 OF AGE MAY BE SENTENCED TO 1 OF THE FOLLOWING:
- 6 (A) TO SERVE NOT MORE THAN TWICE THE TERM OF IMPRISONMENT
- 7 OTHERWISE AUTHORIZED FOR THAT VIOLATION.
- 8 (B) TO PAY NOT MORE THAN TWICE THE FINE OTHERWISE AUTHORIZED
- 9 FOR THAT VIOLATION OR, IF THE VIOLATION IS NOT OTHERWISE
- 10 PUNISHABLE BY A FINE, THE FINE AUTHORIZED UNDER SUBSECTION (2).

- 15 NOT MORE THAN 2 YEARS OR IF THE VIOLATION IS A FELONY PUNISHABLE
- 16 BY IMPRISONMENT FOR NOT MORE THAN 2 YEARS.
- 17 (E) A FINE OF NOT MORE THAN \$4,000.00 IF THE VIOLATION IS A
- 18 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 2 YEARS BUT NOT
- 19 MORE THAN 4 YEARS.
- 20 (F) A FINE OF NOT MORE THAN \$5,000.00 IF THE VIOLATION IS A
- 21 FELONY PUNISHABLE BY IMPRISONMENT FOR 5 YEARS.
- 22 (G) A FINE OF NOT MORE THAN \$10,000.00 IF THE VIOLATION IS A
- 23 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 5 YEARS.
- 24 (3) THIS SECTION APPLIES TO CRIMES COMMITTED ON OR AFTER THE
- 25 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
- 26 (4) AS USED IN THIS SECTION, "VULNERABLE ADULT" MEANS THAT
- 27 TERM AS DEFINED IN SECTION 145M.
