(MCL 333.1101 to 333.25211) by adding section 21052c.

- 2 NOT ENCOURAGE OR DIRECT AN INSURED TO AN EMERGENCY HEALTH SERV-
- 3 ICES RESPONSE AND TRANSPORTATION SYSTEM THAT IS IN COMPETITION
- 4 WITH OR IS A SUBSTITUTION FOR THE 9-1-1 EMERGENCY HEALTH SERVICES
- 5 SYSTEM OR OTHER STATE OR LOCAL UNIT OF GOVERNMENT EMERGENCY
- 6 HEALTH SERVICES SYSTEM.
- 7 (2) SUBSECTION (1) DOES NOT PROHIBIT A HEALTH MAINTENANCE
- 8 ORGANIZATION FROM USING OR REOUIRING TRANSPORTATION OUTSIDE THE
