

SENATE BILL No. 1355

September 20, 2000, Introduced by Senator STEIL and referred to the Committee on Appropriations.

A bill to amend 1984 PA 431, entitled
"The management and budget act,"
(MCL 18.1101 to 18.1594) by adding section 270.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 270. (1) THE DEPARTMENT SHALL ISSUE DIRECTIVES TO ALL
2 STATE AGENCIES TO ENSURE THAT ALL STATE AGENCIES SHALL NOT USE AN
3 AUTOMATED TELEPHONE SYSTEM FOR ANSWERING TELEPHONE CALLS PLACED
4 TO THAT STATE AGENCY'S PRIMARY PUBLIC SERVICE TELEPHONE NUMBERS
5 DURING REGULAR HOURS OF OPERATION, UNLESS THE AUTOMATED TELEPHONE
6 SYSTEM PROVIDES, AS THE FIRST MENU OPTION, AN OPTION THAT PERMITS
7 A CALLER TO SPEAK DIRECTLY TO AN EMPLOYEE OF THAT STATE AGENCY
8 WITHOUT LISTENING TO THE ENTIRE RECORDED MESSAGE. INCOMING TELE-
9 PHONE CALLS ON PRIMARY PUBLIC SERVICE NUMBERS SHALL BE ANSWERED
10 PROMPTLY, AND EACH STATE AGENCY SHALL MONITOR THE LENGTH OF TIME

1 ANY INCOMING CALL IS PUT ON HOLD, WITH THE GOAL OF REDUCING HOLD
2 TIME TO 5 MINUTES OR LESS.

3 (2) AN EMPLOYEE OF A STATE AGENCY SHALL NOT USE AN AUTOMATED
4 PHONE ANSWERING SYSTEM TO SCREEN TELEPHONE CALLS FOR THE PURPOSE
5 OF REFUSING TO COMMUNICATE WITH ANY PERSON IF THE SUBJECT MATTER
6 OF THE TELEPHONE MESSAGE OR THE IDENTITY OF THE CALLER RELATES TO
7 A DUTY OR RESPONSIBILITY OF THE DIVISION OR UNIT OF THE STATE
8 AGENCY FOR WHICH THE EMPLOYEE PERFORMS SERVICES OR RELATES TO A
9 DUTY OR RESPONSIBILITY OF THE EMPLOYEE.

10 (3) THE DEPARTMENT SHALL PERIODICALLY MONITOR EACH STATE
11 AGENCY FOR COMPLIANCE WITH THIS SECTION.
