## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 20196. (1) THE DEPARTMENT SHALL ISSUE A SAFETY ALERT
- 2 TO EACH HEALTH FACILITY OR AGENCY LICENSED UNDER THIS ARTICLE
- 3 THAT UTILIZES HOSPITAL BEDS WITH SAFETY RAILS. THE DEPARTMENT
- 4 SHALL INCLUDE AT LEAST ALL OF THE FOLLOWING IN THE SAFETY ALERT:
- 5 (A) A DESCRIPTION OF THE MOST COMMON WAYS PEOPLE BECOME
- 6 ENTANGLED IN HOSPITAL BED SAFETY RAILS.
- 7 (B) A WARNING THAT HOSPITAL BED SAFETY RAILS SHOULD NOT BE
- 8 USED WITH CERTAIN PATIENTS, INCLUDING A DESCRIPTION OF THOSE
- 9 PATIENTS.
- 10 (C) A STATEMENT URGING AFFECTED HEALTH FACILITIES AND
- 11 AGENCIES TO CLOSELY MONITOR HOSPITAL BEDS WITH SAFETY RAILS FOR

- 11 REQUIRED UNDER SUBSECTION (1) WITH THE INFORMATION CONTAINED IN

- 13 (3) IF A DEATH INVOLVING A PATIENT IN A HOSPITAL BED WITH
- 14 SAFETY RAILS OCCURS IN A HEALTH FACILITY OR AGENCY, AND BOTH OF
- 15 THE FOLLOWING CIRCUMSTANCES OCCUR, THE HEALTH FACILITY OR AGENCY
- 16 SHALL NOTIFY THE FAMILY OF THE DECEASED, IF POSSIBLE:
- 17 (A) THE HEALTH FACILITY IS REQUIRED TO NOTIFY THE COUNTY
- 18 MEDICAL EXAMINER OF THE DEATH UNDER 1953 PA 181, MCL 52.201 TO
- **19** 52.216.
- 20 (B) THE COUNTY MEDICAL EXAMINER IS REQUIRED TO INVESTIGATE
