THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 2607. (1) THE AMOUNT OF A BOND ISSUED TO STAY EXECU-
- 2 TION ON A JUDGMENT WHILE AN APPEAL IS PENDING SHALL BE DETERMINED
- 3 ACCORDING TO THE APPLICABLE MICHIGAN COURT RULES AND STATUTORY
- 4 PROVISIONS. THE BOND SHALL NOT EXCEED \$25,000,000.00 REGARDLESS
- 5 OF THE AMOUNT OF THE JUDGMENT. THE MAXIMUM AMOUNT ALLOWED FOR A
- 6 BOND UNDER THIS SUBSECTION SHALL BE ADJUSTED ON JANUARY 1 FOLLOW-
- 7 ING THE FIFTH YEAR AFTER THE EFFECTIVE DATE OF THE AMENDATORY ACT
- 8 THAT ADDED THIS SECTION AND ON JANUARY 1 EVERY 5 YEARS AFTER THAT
- 9 ADJUSTMENT BY AN AMOUNT DETERMINED BY THE STATE TREASURER TO
- 10 REFLECT THE ANNUAL AGGREGATE PERCENTAGE CHANGE IN THE DETROIT
