

# SENATE BILL No. 1043

January 30, 2002, Introduced by Senators DINGELL and MC COTTER and referred to the Committee on Government Operations.

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16x of chapter XVII (MCL 777.16x), as amended by 2000 PA 473.

**THE PEOPLE OF THE STATE OF MICHIGAN ENACT:**

CHAPTER XVII

Sec. 16x. This chapter applies to the following felonies enumerated in chapter 750 of the Michigan Compiled Laws:
