April 24, 2001, Introduced by Reps. Lipsey, McConico, Frank, Howell, Newell, Switalski, Plakas, Koetje, Quarles, Daniels, Adamini, Phillips, Kolb, Williams, Rich Brown, Waters, Zelenko, Murphy and Hart and referred to the Committee on Criminal Justice.

A bill to amend 1927 PA 175, entitled
"The code of criminal procedure,"
by amending section 15 of chapter XVII (MCL 777.15), as amended
by 2000 PA 279.

CHAPTER XVII
