"An act to prescribe the rights and duties of parties to home solicitation sales,"

(MCL 445.111 to 445.117) by adding section 8.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 8. (1) THE COMMISSION SHALL ESTABLISH AND PROVIDE FOR
- 2 THE OPERATION OF A "DO NOT CALL" REGISTER OF TELEPHONE NUMBERS OF
- 3 RESIDENTIAL TELEPHONE SUBSCRIBERS WHO OBJECT TO RECEIVING TELE-

- 10 THE COMMISSION. AN ENROLLMENT ON THE REGISTER IS EFFECTIVE 30

- 14 (2) THE INFORMATION CONTAINED IN THE DATABASE IS NOT OPEN TO
- 15 PUBLIC INSPECTION OR DISCLOSURE UNDER THE FREEDOM OF INFORMATION
- 16 ACT, 1976 PA 442, MCL 15.231 TO 15.246. THE COMMISSION SHALL
- 17 TAKE ALL NECESSARY STEPS TO PROTECT THE CONFIDENTIALITY OF THE

- 19 (3) THE COMMISSION SHALL FORWARD THE LIST OF MICHIGAN TELE-
- 20 PHONE NUMBERS ON THE REGISTER TO THE FEDERAL COMMUNICATIONS
- 21 COMMISSION'S OR ANY OTHER FEDERAL AGENCY'S "DO NOT CALL" NATIONAL
- 22 DATABASE, IF A FEDERAL LIST IS ESTABLISHED.
- 23 (4) A TELEPHONE SOLICITOR SHALL OBTAIN A COPY OF THE REGIS-
- 24 TER FROM THE COMMISSION BEFORE HE OR SHE MAKES A TELEPHONE SOLIC-

- 25 ITATION IN THIS STATE. A TELEPHONE SOLICITOR SHALL NOT CALL
- 26 TELEPHONE NUMBER LISTED ON THE REGISTER.
