## **SENATE BILL No. 276**

## March 6, 2001, Introduced by Senators JAYE and GOSCHKA and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled

"The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 506b.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 506B. (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS
 ACT, AN INDIVIDUAL CONVICTED OF COMMITTING OR ATTEMPTING TO
 COMMIT A VIOLATION OF THIS ACT IN WHICH THE VICTIM IS A VULNERA BLE ADULT, IS 65 YEARS OF AGE OR OLDER, OR IS LESS THAN 18 YEARS
 OF AGE MAY BE SENTENCED TO 1 OF THE FOLLOWING:

6 (A) TO SERVE NOT MORE THAN TWICE THE TERM OF IMPRISONMENT7 OTHERWISE AUTHORIZED FOR THAT VIOLATION.

8 (B) TO PAY NOT MORE THAN TWICE THE FINE OTHERWISE AUTHORIZED
9 FOR THAT VIOLATION OR, IF THE VIOLATION IS NOT OTHERWISE
10 PUNISHABLE BY A FINE, THE FINE AUTHORIZED UNDER SUBSECTION (2).

(C) TO SERVE BOTH THE TERM OF IMPRISONMENT AUTHORIZED UNDER
 SUBDIVISION (A) AND TO PAY THE FINE AUTHORIZED UNDER SUBDIVISION
 (B).

4 (2) IF THE VIOLATION IS NOT OTHERWISE PUNISHABLE BY A FINE,
5 THE COURT, IN ADDITION TO ANY AUTHORIZED PENALTY, MAY ORDER THE
6 INDIVIDUAL TO PAY A FINE AS FOLLOWS:

7 (A) A FINE OF NOT MORE THAN \$200.00 IF THE VIOLATION IS A8 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR LESS THAN 6 MONTHS.

9 (B) A FINE OF NOT MORE THAN \$500.00 IF THE VIOLATION IS A10 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR 6 MONTHS.

11 (C) A FINE OF NOT MORE THAN \$1,000.00 IF THE VIOLATION IS A12 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR 1 YEAR.

(D) A FINE OF NOT MORE THAN \$2,000.00 IF THE VIOLATION IS A
14 MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR MORE THAN 1 YEAR BUT
15 NOT MORE THAN 2 YEARS OR IF THE VIOLATION IS A FELONY PUNISHABLE
16 BY IMPRISONMENT FOR NOT MORE THAN 2 YEARS.

17 (E) A FINE OF NOT MORE THAN \$4,000.00 IF THE VIOLATION IS A
18 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 2 YEARS BUT NOT
19 MORE THAN 4 YEARS.

20 (F) A FINE OF NOT MORE THAN \$5,000.00 IF THE VIOLATION IS A
21 FELONY PUNISHABLE BY IMPRISONMENT FOR 5 YEARS.

22 (G) A FINE OF NOT MORE THAN \$10,000.00 IF THE VIOLATION IS A23 FELONY PUNISHABLE BY IMPRISONMENT FOR MORE THAN 5 YEARS.

24 (3) THIS SECTION APPLIES TO CRIMES COMMITTED ON OR AFTER THE25 EFFECTIVE DATE OF THE AMENDATORY ACT THAT ADDED THIS SECTION.

26 (4) AS USED IN THIS SECTION, "VULNERABLE ADULT" MEANS THAT27 TERM AS DEFINED IN SECTION 145M.
