A bill to amend 1976 PA 451, entitled "The revised school code,"

(MCL 380.1 to 380.1852) by adding section 1523.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 1523. (1) EXCEPT AS OTHERWISE PROVIDED IN THIS SUBSEC-
- 2 TION, THE BOARD OF A SCHOOL DISTRICT OR LOCAL ACT SCHOOL DISTRICT
- 3 OR BOARD OF DIRECTORS OF A PUBLIC SCHOOL ACADEMY SHALL REQUIRE
- 4 EACH PERSON IT EMPLOYS AS A COACH OF AN INTERSCHOLASTIC ATHLETIC
- 5 ACTIVITY, OR ASSIGNS TO SERVE AS A COACH OF AN INTERSCHOLASTIC
- 6 ATHLETIC ACTIVITY, TO HOLD VALID CERTIFICATION IN SPORT SAFETY
- 7 TRAINING. THE CERTIFICATION SHALL BE CURRENT DURING THE ENTIRE
- 8 INTERSCHOLASTIC SEASON FOR THE ATHLETIC ACTIVITY THE PERSON IS
- 9 COACHING. CERTIFICATION IN SPORT SAFETY TRAINING MAY BE ACHIEVED
- 10 BY SUCCESSFUL COMPLETION OF THE SPORT SAFETY TRAINING COURSE
- 11 OFFERED BY THE AMERICAN RED CROSS OR BY SUCCESSFUL COMPLETION OF

- 1 AN EOUIVALENT COURSE APPROVED BY THE STATE BOARD. THIS
- 2 REQUIREMENT DOES NOT APPLY TO A PERSON WHO DEMONSTRATES THAT HE
- 3 OR SHE HAS PHYSICAL LIMITATIONS THAT MAKE IT IMPRACTICABLE FOR
- 4 THE PERSON TO COMPLETE THE COURSE AND OBTAIN THE REQUIRED CERTI-

- 6 (2) AFTER A PERSON IS DETERMINED TO MEET THE CERTIFICATION

- 11 REQUIREMENTS OF SUBSECTION (1). IF THE PERSON DOES NOT PROVIDE
- 12 THIS DOCUMENTATION, THE BOARD OR BOARD OF DIRECTORS SHALL NOT
- 13 ALLOW THE PERSON TO COACH AN INTERSCHOLASTIC ATHLETIC ACTIVITY.
- 14 THIS REQUIREMENT DOES NOT APPLY TO A PERSON WHO DEMONSTRATES THAT
- 15 HE OR SHE HAS PHYSICAL LIMITATIONS THAT MAKE IT IMPRACTICABLE FOR
- 16 THE PERSON TO COMPLETE THE COURSE AND OBTAIN THE REQUIRED CERTI-
- 17 FICATION UNDER THIS SUBSECTION.
- 18 (3) A PERSON WHO MEETS THE SPORT SAFETY CERTIFICATION
- 19 REQUIREMENTS UNDER THIS SECTION AND WHO PROVIDES PHYSICAL AID TO
- 20 ANOTHER PERSON IN THE COURSE OF HIS OR HER EMPLOYMENT OR SERVICE
- 21 AS A COACH IS NOT LIABLE IN A CIVIL ACTION FOR DAMAGES RESULTING
- 22 FROM AN ACT OR OMISSION OCCURRING IN PROVIDING THAT AID EXCEPT AN
- 23 ACT OR OMISSION CONSTITUTING GROSS NEGLIGENCE OR WILLFUL AND
- 24 WANTON MISCONDUCT.
