

SENATE BILL No. 939

December 11, 2001, Introduced by Senators SCHWARZ, SHUGARS, BULLARD,
VAN REGENMORTER, JOHNSON, MC MANUS, SIKKEMA, GOUGEON,
HAMMERSTROM, NORTH, GARCIA, SANBORN, SCHUETTE, GOSCHKA,
STEIL and STILLE and referred to the Committee on Judiciary.

A bill to amend 1931 PA 328, entitled
"The Michigan penal code,"
(MCL 750.1 to 750.568) by adding section 411t.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 411T. (1) A PERSON SHALL NOT OBTAIN OR POSSESS A BLUE-
2 PRINT, EVACUATION PLAN, OR OTHER DIAGRAM OR DESCRIPTION OF A
3 PUBLIC BUILDING, OR ENGAGE IN SURVEILLANCE OF A PUBLIC BUILDING,
4 FOR THE PURPOSE OF COMMITTING A FELONY WITH THE INTENT TO DO ANY
5 OF THE FOLLOWING:

6 (A) INTIMIDATE OR COERCE A CIVILIAN POPULATION OF THIS STATE
7 OR A LOCAL UNIT OF GOVERNMENT OF THIS STATE.

8 (B) INFLUENCE THE POLICY OF THIS STATE OR A LOCAL UNIT OF
9 GOVERNMENT OF THIS STATE BY INTIMIDATION OR COERCION.

1 (C) AFFECT THE CONDUCT OF THIS STATE OR A LOCAL UNIT OF
2 GOVERNMENT OF THIS STATE BY MURDER, ASSASSINATION, OR
3 KIDNAPPING.

4 (2) EXCEPT AS PROVIDED IN SUBSECTION (3), A PERSON WHO VIO-
5 LATES THIS SECTION IS GUILTY OF A FELONY PUNISHABLE BY IMPRISON-
6 MENT FOR LIFE OR ANY TERM OF YEARS OR A FINE OF NOT MORE THAN
7 \$20,000.00, OR BOTH.

8 (3) IF THE VIOLATION CAUSES DEATH TO ANY INDIVIDUAL, THE
9 PERSON IS GUILTY OF A FELONY AND SHALL BE PUNISHED BY IMPRISON-
10 MENT FOR LIFE WITHOUT THE OPPORTUNITY FOR PAROLE AND MAY BE FINED
11 NOT MORE THAN \$50,000.00.

12 (4) AS USED IN THIS SECTION, "PUBLIC BUILDING" INCLUDES BOTH
13 OF THE FOLLOWING:

14 (A) A BUILDING OWNED OR OPERATED BY FEDERAL, STATE, OR LOCAL
15 GOVERNMENT OR BY A PUBLIC UNIVERSITY.

16 (B) A PRIVATELY OWNED BUILDING, ENCLOSURE, OR OTHER FACILI-
17 TY, ALL OR PART OF WHICH IS REGULARLY OPEN TO THE PUBLIC.
