

# SENATE BILL No. 1353

May 22, 2002, Introduced by Senators STILLE, HAMMERSTROM, JOHNSON, EMMONS, SCHWARZ, BENNETT, DUNASKISS, MC COTTER and DE BEAUSSAERT and referred to the Committee on Finance.

A bill to amend 1967 PA 281, entitled  
"Income tax act of 1967,"  
(MCL 206.1 to 206.532) by adding section 438.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1        SEC. 438. (1) FOR THE 2001 TAX YEAR AND EACH TAX YEAR AFTER  
2 THE 2001 TAX YEAR, AN INDIVIDUAL MAY DESIGNATE ON HIS OR HER  
3 ANNUAL RETURN THAT A CONTRIBUTION OF \$2.00 OR MORE OF HIS OR HER  
4 REFUND BE CREDITED TO THE AMANDA'S FUND FOR BREAST CANCER  
5 RESEARCH CREATED IN THE AMANDA'S FUND FOR BREAST CANCER RESEARCH  
6 ACT. IF AN INDIVIDUAL'S REFUND IS NOT SUFFICIENT TO MAKE A CON-  
7 TRIBUTION UNDER THIS SECTION, THE INDIVIDUAL MAY DESIGNATE A CON-  
8 TRIBUTION AMOUNT AND THAT CONTRIBUTION AMOUNT SHALL BE ADDED TO  
9 THE INDIVIDUAL'S TAX LIABILITY FOR THE TAX YEAR.

1       (2) THE TAX DESIGNATION AUTHORIZED IN THIS SECTION SHALL BE  
2 CLEARLY AND UNAMBIGUOUSLY PRINTED ON THE FIRST PAGE OF THE STATE  
3 INDIVIDUAL INCOME TAX RETURN FORMS AS AMANDA'S FUND FOR BREAST  
4 CANCER RESEARCH.

5       (3) NOTWITHSTANDING ANY OTHER ALLOCATIONS OR DISBURSEMENTS  
6 REQUIRED BY THIS ACT, EACH YEAR THAT THE CONTRIBUTION DESIGNATION  
7 UNDER THIS SECTION IS IN EFFECT, AN AMOUNT EQUAL TO THE CUMULA-  
8 TIVE DESIGNATION MADE UNDER THIS SECTION, LESS THE AMOUNT APPRO-  
9 PRIATED TO THE DEPARTMENT TO IMPLEMENT THIS SECTION, SHALL BE  
10 APPROPRIATED FROM THE GENERAL FUND AND DEPOSITED IN THE AMANDA'S  
11 FUND FOR BREAST CANCER RESEARCH CREATED IN THE AMANDA'S FUND FOR  
12 BREAST CANCER RESEARCH ACT AND SHALL BE USED SOLELY FOR THE PUR-  
13 POSES OF THAT FUND.

14       Enacting section 1. This amendatory act does not take  
15 effect unless Senate Bill No. 1354  
16                               of the 91st Legislature is enacted into  
17 law.
