4 (3) "Qualified person" means a claimant and any person, dom-5 iciled in Michigan, who can be claimed as a dependent under the 6 internal revenue code and who does not file a claim under this 7 act for the same tax year. The term does not include the addi-8 tional exemptions allowed for age or blindness.

9 (4) "Renter" means a person who rents or leases a 10 homestead.
