THE COMMISSIONER SHALL DISTRIBUTE THE GUIDE TO MEM-13 BERS OF THE PUBLIC UPON REQUEST AND SHALL PROVIDE ACCESS TO THE 14 CONSUMER GUIDE THROUGH THE INTERNET.
