SENATE SUBSTITUTE FOR HOUSE BILL NO. 4907

A bill to amend 1956 PA 218, entitled
"The insurance code of 1956,"
by amending section 602 (MCL 500.602), as amended by 1989 PA 35, and by adding section 603.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 602. (1) "Life" insurance is insurance upon the lives
- 2 and health of persons and every insurance pertaining thereto, and
- 3 to grant, purchase, or dispose of annuities. Notwithstanding any
- 4 other provision of law, life insurance includes insurance upon
- 5 the lives of persons which insurance prepays -in a lump sum not
- 6 more than 25% of the death benefit. based on 1 or more of the
- 7 following medical conditions if considered to be life threatening
- 8 or of a catastrophic nature:
- 9 —— (a) Malignant tumors.
- 10 (b) Conditions requiring organ transplantation.

- 1 (c) Coronary artery disease resulting in acute infarction or
- 2 requiring surgery.
- 3 (d) Permanent neurological deficit resulting from cerebral
- 4 vascular accident.
- 5 (e) Endstage renal failure.
- 6 —— (f) Other medical conditions which the commissioner finds,
- 7 after an opportunity for a hearing pursuant to the administrative
- 8 procedures act of 1969, Act No. 306 of the Public Acts of 1969,
- 9 being sections 24.201 to 24.328 of the Michigan Compiled Laws, to
- 10 be either life threatening or of a catastrophic nature.
- 11 (2) Transaction of life insurance includes the issuance of
- 12 policies of life and endowment insurance and contracts for the
- 13 payment of annuities and pure endowments, and contracts
- 14 supplemental thereto which to those that contain only those
- 15 provisions relating to accident and sickness insurance as provide
- 16 additional benefits in case of for death or dismemberment or
- 17 loss of sight by accident or as operate to safeguard those
- 18 policies or contracts against lapse or to give a special
- 19 surrender value or special benefit or an annuity if the insured
- 20 or annuitant shall become totally and permanently disabled, as
- 21 defined by the contract or supplemental contract.
- 22 (3) All corporations, associations, partnerships, or
- 23 individuals, doing business in this state under any charter,
- 24 compact, agreement, or statute of this or any other state,
- 25 involving an insurance, guaranty, contract, or pledge, for the
- 26 payment of annuities or endowments, or for the payment of money
- 27 to families, or representatives of policy or certificate holders

- 1 or members, -shall be are considered -and deemed to be life
- 2 insurance companies within the meaning of the laws relating to
- 3 life insurance within this state.
- 4 Sec. 603. (1) As used in this section:
- 5 (a) "Accelerated benefits" means benefits payable under a
- 6 life insurance contract to a policyowner or certificateholder,
- 7 during the lifetime of the insured, in anticipation of death or
- 8 upon the occurrence of specified life-threatening or catastrophic
- 9 conditions as defined by the policy or rider that reduce the
- 10 death benefit otherwise payable under the life insurance contract
- 11 and that are payable upon the occurrence of a single qualifying
- 12 event that results in the payment of a benefit amount fixed at
- 13 the time of acceleration.
- (b) "Qualifying event" means 1 or more of the following:
- 15 (i) A medical condition that would result in a drastically
- 16 limited life span as specified in the contract.
- 17 (ii) A medical condition that has required or requires
- 18 extraordinary medical intervention including, but not limited to,
- 19 major organ transplant or continuous artificial life support,
- 20 without which the insured would die.
- 21 (iii) A condition that usually requires continuous
- 22 confinement in an eligible institution as defined in the contract
- 23 if the insured is expected to remain there for the rest of his or
- 24 her life.
- 25 (iv) A medical condition that would, in the absence of
- 26 extensive or extraordinary medical treatment, result in a
- 27 drastically limited life span. Such conditions may include, but

- 1 are not limited to, coronary artery disease resulting in an acute
- 2 infarction or requiring surgery, permanent neurological deficit
- 3 resulting from cerebral vascular accident, end stage renal
- 4 failure, acquired immune deficiency syndrome, or other medical
- 5 conditions that the commissioner has approved for any particular
- 6 filing.
- 7 (v) Other qualifying events that the commissioner approves
- 8 for a particular filing.
- 9 (2) An accelerated benefit rider and a life insurance policy
- 10 with accelerated benefit provisions are primarily mortality risks
- 11 rather than morbidity risks and are life insurance benefits
- 12 subject to all of the following:
- 13 (a) Chapters 40 and 44.
- 14 (b) Shall provide the option to take the benefit as a lump
- 15 sum and not as an annuity contingent upon the life of the
- 16 insured.
- 17 (c) Shall have no restrictions on the use of the proceeds.
- 18 (d) If any death benefit remains after payment of an
- 19 accelerated benefit, shall not affect the accidental death
- 20 benefit provision, if any, by the payment of the accelerated
- 21 benefit.
- (e) Shall include the terminology "accelerated benefit" in
- 23 the descriptive title and not be described or marketed as
- 24 long-term care insurance or as providing long-term care
- 25 benefits.
- 26 (3) Except as otherwise provided, the insurer of an
- 27 accelerated benefit rider or life insurance policy with

- 1 accelerated benefit provisions is required to obtain from an
- 2 assignee or irrevocable beneficiary a signed acknowledgment of
- 3 concurrence for payout prior to the payment of the accelerated
- 4 benefit. If the insurer making the accelerated benefit is itself
- 5 the assignee under the policy, an acknowledgment is not
- 6 required.
- 7 (4) An insurer of an accelerated benefit rider or life
- 8 insurance policy with accelerated benefit provisions shall
- 9 provide a disclosure statement at the time of application and at
- 10 the time the accelerated benefit payment request is submitted
- 11 that receipt of these accelerated benefits may be taxable and
- 12 that assistance should be sought from a personal tax advisor.
- 13 The disclosure statement shall be prominently displayed on the
- 14 first page of the policy or rider and any other related
- 15 documents. If a policyowner or certificateholder of an
- 16 accelerated benefit rider or life insurance policy with
- 17 accelerated benefit provisions requests an acceleration, the
- 18 insurer shall send a statement to the policyowner or
- 19 certificateholder and irrevocable beneficiary showing any effect
- 20 that the payment of the accelerated benefit will have on the
- 21 policy's cash value, accumulation account, death benefit,
- 22 premium, policy loans, and policy liens. The statement shall
- 23 disclose that receipt of accelerated benefit payments may
- 24 adversely affect the recipient's eligibility for medicaid or
- 25 other government benefits or entitlements, may be taxable, and
- 26 that assistance should be sought from a personal tax advisor. If
- 27 a previous disclosure statement becomes invalid as a result of an

- 1 acceleration of the death benefit, the insurer shall send a
- 2 revised disclosure statement to the policyowner or
- 3 certificateholder and irrevocable beneficiary. If the insurer
- 4 agrees to accelerate death benefits, the insurer shall issue an
- 5 amended schedule page to the policyholder to reflect, or shall
- 6 notify the certificateholder under a group policy of, any new,
- 7 reduced in-force face amount of the contract.
- 8 (5) A written disclosure, including, but not necessarily
- 9 limited to, a brief description of the accelerated benefit and
- 10 definitions of the conditions or occurrences triggering payment
- 11 of the benefits shall be given to the applicant for an
- 12 accelerated benefit rider or life insurance policy with
- 13 accelerated benefit provisions. The description shall include an
- 14 explanation of any effect of the payment of a benefit on the
- 15 policy's cash value, accumulation account, death benefit,
- 16 premium, policy loans, and policy liens. For agent solicited
- 17 insurance, the agent shall provide the disclosure form to the
- 18 applicant prior to or concurrently with the application.
- 19 Acknowledgment of the disclosure shall be signed by the applicant
- 20 and writing agent. For a solicitation by direct response
- 21 methods, the insurer shall provide the disclosure form to the
- 22 applicant at the time the policy is delivered, with a notice that
- 23 a full premium refund shall be received if the policy is returned
- 24 to the company within the free look period. For group insurance
- 25 policies, the disclosure form shall be contained as part of the
- 26 certificate of coverage or any related document furnished by the
- 27 insurer for the certificateholder.

- 1 (6) If there is a premium or cost of insurance charge, the
- 2 insurer shall give the applicant for an accelerated benefit rider
- 3 or life insurance policy with accelerated benefit provisions a
- 4 generic illustration numerically demonstrating any effect of the
- 5 payment of a benefit on the policy's cash value, accumulation
- 6 account, death benefit, premium, policy loans, and policy liens.
- 7 For agent solicited insurance, the agent shall provide the
- 8 illustration to the applicant prior to or concurrently with the
- 9 application. For a solicitation by direct response methods, the
- 10 insurer shall provide the illustration to the applicant at the
- 11 time the policy is delivered. For group insurance policies, the
- 12 disclosure form shall be contained as part of the certificate of
- 13 coverage or any related document furnished by the insurer for the
- 14 certificateholder.
- 15 (7) An insurer of an accelerated benefit rider or life
- 16 insurance policy with accelerated benefit provisions with
- 17 financing options other than as described in subsection (12)(b)
- 18 shall disclose to the policyowner any premium or cost of
- 19 insurance charge for the accelerated benefit. The insurer shall
- 20 make a reasonable effort to assure that the certificateholder is
- 21 aware of any additional premium or cost of insurance charge if
- 22 the certificateholder is required to pay a charge. Upon request
- 23 of the commissioner, an insurer shall furnish an actuarial
- 24 demonstration disclosing the method of arriving at its cost for
- 25 the accelerated benefit.
- 26 (8) The insurer of an accelerated benefit rider or life
- 27 insurance policy with accelerated benefit provisions shall

- 1 disclose to the policyowner any administrative expense charge.
- 2 The insurer shall make a reasonable effort to assure that the
- 3 certificateholder is aware of any administrative expense charge
- 4 if the certificateholder is required to pay the charge.
- 5 (9) An accelerated benefit provision shall be effective as
- 6 follows:
- 7 (a) On the effective date of the policy or rider for
- 8 accidents.
- 9 (b) No more than 30 days after the effective date of the
- 10 policy or rider for illness.
- 11 (10) The insurer of an accelerated benefit rider or life
- 12 insurance policy with accelerated benefit provisions may offer a
- 13 waiver of premium for the accelerated benefit provision in the
- 14 absence of a regular waiver of premium provision being in
- 15 effect. At the time the benefit is claimed, the insurer shall
- 16 explain any continuing premium requirement to keep the policy in
- 17 force.
- 18 (11) An insurer of an accelerated benefit rider or life
- 19 insurance policy with accelerated benefit provisions shall not
- 20 unfairly discriminate among insureds with differing qualifying
- 21 events covered under the policy or among insureds with similar
- 22 qualifying events covered under the policy. An insurer shall not
- 23 apply further conditions on the payment of the accelerated
- 24 benefits other than those conditions specified in the policy or
- 25 rider.
- 26 (12) The insurer of an accelerated benefit rider or life
- 27 insurance policy with accelerated benefit provisions may do any

- 1 of the following:
- 2 (a) Require a premium charge or cost of insurance charge for
- 3 the accelerated benefit if based on sound actuarial principles.
- 4 For group insurance, the additional cost may also be reflected in
- 5 the experience rating.
- 6 (b) Pay a present value of the face amount. The calculation
- 7 shall be based on any applicable actuarial discount appropriate
- 8 to the policy design. The interest rate or interest rate
- 9 methodology used in the calculation shall be based on sound
- 10 actuarial principles and disclosed in the contract or actuarial
- 11 memorandum. The maximum interest rate used shall be no greater
- 12 than the greater of the current yield on 90-day treasury bills or
- 13 the current maximum statutory adjustable policy loan interest
- 14 rate.
- 15 (c) Accrue an interest charge on the amount of the
- 16 accelerated benefits. The interest rate or interest rate
- 17 methodology used in the calculation shall be based on sound
- 18 actuarial principles and disclosed in the contract or actuarial
- 19 memorandum. The maximum interest rate used shall be no greater
- 20 than the greater of the current yield on 90-day treasury bills or
- 21 the current maximum statutory adjustable policy loan interest
- 22 rate. The interest rate accrued on the portion of the lien that
- 23 is equal in amount to the cash value of the contract at the time
- 24 of the benefit acceleration shall be no more than the policy loan
- 25 interest rate stated in the contract.
- 26 (13) Except as otherwise provided in this subsection, if an
- 27 accelerated benefit on an accelerated benefit rider or life

- 1 insurance policy with accelerated benefit provisions is payable,
- 2 there shall be no more than a pro rata reduction in the cash
- 3 value based on the percentage of death benefits accelerated to
- 4 produce the accelerated benefit payment. Alternatively, the
- 5 payment of accelerated benefits, any administrative expense
- 6 charges, any future premiums, and any accrued interest may be
- 7 considered a lien against the death benefit of the policy or
- 8 rider and the access to the cash value may be restricted to any
- 9 excess of the cash value over the sum of any other outstanding
- 10 loans and the lien. Future access to additional policy loans may
- 11 be limited to any excess of the cash value over the sum of the
- 12 lien and any other outstanding policy loans.
- 13 (14) If payment of an accelerated benefit on an accelerated
- 14 benefit rider or life insurance policy with accelerated benefit
- 15 provisions results in a pro rata reduction in the cash value, the
- 16 payment may not be applied toward repaying an amount greater than
- 17 a pro rata portion of any outstanding policy loans.
- 18 (15) For an accelerated benefit rider or life insurance
- 19 policy with accelerated benefit provisions, a qualified actuary
- 20 shall describe the accelerated benefits, the risks, the expected
- 21 costs, and the calculation of statutory reserves in an actuarial
- 22 memorandum. The insurer shall maintain in its files descriptions
- 23 of the bases and procedures used to calculate benefits payable.
- 24 These descriptions and the actuarial memorandum shall be made
- 25 available for examination by the commissioner upon request.
- 26 (16) If benefits are provided through the acceleration of
- 27 benefits under group or individual life policies or riders to an

- 1 accelerated benefit rider or life insurance policy with
- 2 accelerated benefit provisions, policy reserves shall be
- 3 determined in accordance with section 834. All valuation
- 4 assumptions used in constructing the reserves shall be determined
- 5 as appropriate for statutory valuation purposes by a member in
- 6 good standing of the American academy of actuaries. The actuary
- 7 shall follow both actuarial standards and certification for good
- 8 and sufficient reserves. Reserves in the aggregate should be
- 9 sufficient to cover policies upon which no claim has yet arisen
- 10 and policies upon which an accelerated claim has arisen. For
- 11 policies and certificates that provide actuarially equivalent
- 12 benefits, additional reserves do not need to be established.
- 13 Policy liens and policy loans, including accrued interest,
- 14 represent assets of the insurer for statutory reporting
- 15 purposes. For a policy on which the policy lien exceeds the
- 16 policy's statutory reserve liability, the excess shall be held as
- 17 a nonadmitted asset.
