- 3 (B) PROVIDE OR OPERATE, WITH OR WITHOUT REMUNERATION,
- 4 FACILITIES FOR COMPUTER-ASSISTED SHOOTING.
- 5 (C) PROVIDE OR OFFER TO PROVIDE, WITH OR WITHOUT REMUNERATION,
- 6 EQUIPMENT SPECIALLY ADAPTED FOR COMPUTER-ASSISTED SHOOTING. THIS
- 7 SUBDIVISION DOES NOT PROHIBIT PROVIDING OR OFFERING TO PROVIDE ANY
- 8 OF THE FOLLOWING:
- 9 (i) GENERAL-PURPOSE EQUIPMENT, INCLUDING A COMPUTER, A CAMERA,
