SUBSTITUTE FOR HOUSE BILL NO. 4714

A bill to amend 1994 PA 451, entitled
"Natural resources and environmental protection act,"

(MCL 324.101 to 324.90106) by adding section 41321; and to repeal acts and parts of acts.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 41321. (1) THE INVASIVE SPECIES ADVISORY COUNCIL IS
- 2 CREATED IN THE DEPARTMENT.
- 3 (2) THE COUNCIL SHALL CONSIST OF ALL OF THE FOLLOWING MEMBERS:
- 4 (A) THE DIRECTOR OF THE DEPARTMENT OF NATURAL RESOURCES, OR
- 5 HIS OR HER DESIGNEE.
- 6 (B) THE DIRECTOR OF THE DEPARTMENT OF AGRICULTURE, OR HIS OR
- 7 HER DESIGNEE.
- 8 (C) THE DIRECTOR OF THE DEPARTMENT OF ENVIRONMENTAL QUALITY,

- 1 OR HIS OR HER DESIGNEE.
- 2 (3) THE FIRST MEETING OF THE COUNCIL SHALL BE CALLED BY THE
- 3 DIRECTOR OF THE DEPARTMENT OF NATURAL RESOURCES. AT THE FIRST
- 4 MEETING, THE COUNCIL SHALL ELECT FROM AMONG ITS MEMBERS A
- 5 CHAIRPERSON AND OTHER OFFICERS AS IT CONSIDERS NECESSARY OR
- 6 APPROPRIATE. AFTER THE FIRST MEETING, THE COUNCIL SHALL MEET AT
- 7 LEAST QUARTERLY, OR MORE FREQUENTLY AT THE CALL OF THE CHAIRPERSON
- 8 OR IF REOUESTED BY A MEMBER.
- 9 (4) A MAJORITY OF THE MEMBERS OF THE COUNCIL CONSTITUTE A
- 10 QUORUM FOR THE TRANSACTION OF BUSINESS AT A MEETING OF THE COUNCIL.
- 11 A MAJORITY OF THE MEMBERS OF THE COUNCIL ARE REQUIRED FOR OFFICIAL
- 12 ACTION OF THE COUNCIL.
- 13 (5) THE BUSINESS THAT THE COUNCIL MAY PERFORM SHALL BE
- 14 CONDUCTED AT A PUBLIC MEETING OF THE COUNCIL HELD IN COMPLIANCE
- 15 WITH THE OPEN MEETINGS ACT, 1976 PA 267, MCL 15.261 TO 15.275.
- 16 (6) A WRITING PREPARED, OWNED, USED, IN THE POSSESSION OF, OR
- 17 RETAINED BY THE COUNCIL IN THE PERFORMANCE OF AN OFFICIAL FUNCTION
- 18 IS SUBJECT TO THE FREEDOM OF INFORMATION ACT, 1976 PA 442, MCL
- 19 15.231 TO 15.246.
- 20 (7) MEMBERS OF THE COUNCIL SHALL SERVE WITHOUT ADDITIONAL
- 21 COMPENSATION. HOWEVER, MEMBERS OF THE COUNCIL MAY BE REIMBURSED FOR
- 22 THEIR ACTUAL AND NECESSARY EXPENSES INCURRED IN THE PERFORMANCE OF
- 23 THEIR OFFICIAL DUTIES AS MEMBERS OF THE COUNCIL.
- 24 (8) THE DEPARTMENT OF NATURAL RESOURCES, THE DEPARTMENT OF
- 25 AGRICULTURE, AND THE DEPARTMENT OF ENVIRONMENTAL QUALITY SHALL
- 26 PROVIDE STAFF AND SERVICES TO THE COUNCIL.
- 27 (9) THE COUNCIL SHALL CONSULT WITH REPRESENTATIVES OF

- BUSINESSES AFFECTED BY THIS PART, ACADEMIC EXPERTS, PUBLIC INTEREST 1
- 2 GROUP REPRESENTATIVES, GOVERNMENT OFFICIALS, AND OTHERS AS
- 3 NECESSARY FOR THE EXERCISE OF ITS POWERS AND PERFORMANCE OF ITS
- DUTIES UNDER THIS PART.
- 5 (10) THIS SECTION IS REPEALED 5 YEARS AFTER THE EFFECTIVE DATE
- OF THE AMENDATORY ACT THAT ADDED THIS SECTION.
- 7 Enacting section 1. This amendatory act does not take effect
