## HOUSE BILL NO. 6248

A bill to amend 1956 PA 218, entitled "The insurance code of 1956,"

(MCL 500.100 to 500.8302) by adding section 126.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

SEC. 126. (1) A WAIVER OF CUSTOMER LIABILITY AGREEMENT IS NOT
INSURANCE OR THE BUSINESS OF INSURANCE AND IS NOT SUBJECT TO THIS
ACT.

4 (2) AS USED IN THIS SECTION:

5 (A) "SERVICE PROVIDER" MEANS A PUBLIC OR PRIVATE PROVIDER OF 6 ELECTRICITY, NATURAL GAS, WATER, SEWER, SOLID WASTE COLLECTION, OR 7 ANY OTHER SIMILAR SERVICE, AND ANY PROVIDER OF COMMUNICATIONS 8 SERVICES INVOLVING THE TRANSMISSION OF DATA OR ANY OTHER 9 INFORMATION OR SIGNALS UTILIZING ANY MEDIUM OR METHOD, INCLUDING, 10 BUT NOT LIMITED TO, CABLE OR BROADBAND SERVICE, IP-ENABLED VOICE

SERVICE, CELLULAR OR MOBILE SERVICE, OR ANY OTHER SIMILAR SERVICE. 1 2 (B) "WAIVER OF CUSTOMER LIABILITY AGREEMENT" MEANS AN OPTIONAL 3 AGREEMENT BETWEEN A SERVICE PROVIDER AND A CUSTOMER OF THE SERVICE 4 PROVIDER UNDER WHICH THE SERVICE PROVIDER AGREES, IN RETURN FOR A 5 SPECIFIED CHARGE PAYABLE BY THE CUSTOMER TO THE SERVICE PROVIDER, 6 TO WAIVE ALL OR A PORTION OF THE CUSTOMER'S LIABILITY TO THE SERVICE PROVIDER FOR INCURRED CHARGES DURING A DEFINED PERIOD IN 7 THE EVENT OF ANY 1 OR MORE OF THE FOLLOWING: THE CUSTOMER'S CALL TO 8 9 ACTIVE MILITARY SERVICE; INVOLUNTARY UNEMPLOYMENT; DEATH; 10 DISABILITY; HOSPITALIZATION; MARRIAGE; DIVORCE; EVACUATION; 11 DISPLACEMENT DUE TO NATURAL DISASTER OR OTHER CAUSE; QUALIFICATION 12 FOR FAMILY LEAVE; OR SIMILAR QUALIFYING EVENT OR CONDITION. A WAIVER OF CUSTOMER LIABILITY MAY BE CONTAINED IN THE AGREEMENT 13 14 UNDER WHICH THE SERVICE PROVIDER PROVIDES SERVICES TO THE CUSTOMER 15 OR IN A SEPARATE AGREEMENT BETWEEN THE SERVICE PROVIDER AND THE 16 CUSTOMER.
