A bill to amend 1994 PA 451, entitled

- 2 (A) "CONVENTIONAL GRAVITY SEWER EXTENSION" MEANS THE

- 1 (C) "FUND" MEANS THE INFRASTRUCTURE CONSTRUCTION FUND CREATED

- 3 (D) -(a) "Governmental agencies" means local units of
- 4 government, metropolitan districts, or other units of government or
- 5 the officers of the units of government authorized to own,
- 6 construct, or operate sewerage systems to serve the public.
- 7 (E) "LICENSED PROFESSIONAL ENGINEER" MEANS A PROFESSIONAL
- 8 ENGINEER LICENSED UNDER ARTICLE 20 OF THE OCCUPATIONAL CODE, 1980
- 9 PA 299, MCL 339.2001 TO 339.2014.
- 10 (F) -(b) "Plans and specifications" means a true description
- 11 or representation of the entire sewerage system and parts of a
- 12 system proposed or operated by a person as the -same SEWERAGE
- 13 SYSTEM exists or is to be constructed, and also a full and fair
- 14 statement of how the system is to be operated.
- 15 (G) "PROJECT" MEANS A PROPOSAL TO INSTALL WITHIN 1 GENERAL
- 16 AREA A NEW WASTEWATER COLLECTION SYSTEM. SYSTEMS PROPOSED FOR
- 17 CONSTRUCTION ON SEPARATE LAND PARCELS SHALL BE CONSIDERED SEPARATE
- 18 PROJECTS.
- 19 (H) -(c) "Sewerage system" means a system of pipes and
- 20 structures including pipes, channels, conduits, manholes, pumping
- 21 stations, sewage or waste treatment works, diversion and regulatory
- 22 devices, outfall structures, and appurtenances, collectively or
- 23 severally, actually used or intended for use by the public for the
- 24 purpose of collecting, conveying, transporting, treating, or
- 25 otherwise handling sanitary sewage or other industrial liquid
- 26 wastes that are capable of adversely affecting the public health.
- 27 (I) "SIMPLE PUMPING STATION AND FORCE MAIN" MEANS THE

- 1 INSTALLATION OF A DUPLEX PUMPING STATION AND A FORCE MAIN WITH ONLY
- 2 1 HIGH POINT AND OF LENGTH OF NO MORE THAN 2,000 FEET THAT IS TO BE
- 3 CONNECTED TO AN EXISTING GRAVITY COLLECTION SYSTEM TO PROVIDE SEWER
- 4 SERVICE TO NEW AREAS PREVIOUSLY NOT SERVED BY THE PUBLIC SEWER
- 5 SYSTEM.
- 6 (J) "SMALL DIAMETER PRESSURE SEWER AND GRINDER PUMPING
- 7 STATION" MEANS A SINGLE PROJECT THAT INCLUDES THE INSTALLATION OF
- 8 NEW PRESSURE SEWERS TOTALING NOT MORE THAN 5,000 FEET AND NOT MORE
- 9 THAN 25 GRINDER PUMPING STATIONS WITH EACH GRINDER PUMPING STATION
- 10 SERVING NOT MORE THAN 5 SEPARATE OWNERS AND THAT IS TO BE CONNECTED
- 11 TO AN EXISTING GRAVITY COLLECTION SYSTEM TO PROVIDE SEWER SERVICE
- 12 TO NEW AREAS PREVIOUSLY NOT SERVED BY THE PUBLIC SEWER SYSTEM.

- 14 village, the township supervisor of each township, the responsible

- 4 299.2945 OF THE MICHIGAN ADMINISTRATIVE CODE AND THE APPLICATION
- 5 FORM PROVIDED BY THE DEPARTMENT RELATED TO THE REQUESTED
- 6 MODIFICATION. WRITTEN APPROVAL FROM THE DEPARTMENT SHALL BE

- 9 FUND CREATED IN SECTION 16A OF THE SHARED CREDIT RATING ACT, 1985

- 11 (4) A PERSON REQUESTING AN EXPEDITED REVIEW SHALL DO ALL OF
- 12 THE FOLLOWING:
- 13 (A) AT LEAST 10 BUSINESS DAYS PRIOR TO SUBMITTING AN
- 14 APPLICATION UNDER SUBDIVISION (B), NOTIFY THE DEPARTMENT
- 15 ELECTRONICALLY, IN ACCORDANCE WITH THE INSTRUCTIONS PROVIDED ON THE
- 16 DEPARTMENT'S WEBSITE, OF HIS OR HER INTENT TO REQUEST EXPEDITED
- 17 REVIEW.
- 18 (B) SUBMIT ELECTRONICALLY A COMPLETE APPLICATION FOR A

- 25 POSTMARKED NOT LATER THAN THE SAME DATE THAT THE APPLICATION IS
- 26 SUBMITTED ELECTRONICALLY.
- 27 (D) FOR NONGOVERNMENTAL ENTITIES, PROVIDE CERTIFICATION TO THE

- 1 DEPARTMENT THAT ALL NECESSARY CONTRACTUAL SERVICE AGREEMENTS AND
- 2 FINANCIAL PLANS ARE IN PLACE.
- 3 (5) EXCEPT AS PROVIDED IN SUBSECTION (7), THE FEE FOR AN
- 4 EXPEDITED REVIEW IS AS FOLLOWS:
- 5 (A) FOR A CONVENTIONAL GRAVITY SEWER EXTENSION LESS THAN 2,000
- 6 FEET, \$1,000.00.
- 7 (B) FOR A CONVENTIONAL GRAVITY SEWER EXTENSION EQUAL TO OR
- 8 GREATER THAN 2,000 FEET BUT LESS THAN 4,000 FEET OF SEWER LINE,
- 9 \$1,500.00, AND FOR EACH INCREMENTAL INCREASE OF UP TO 2,000 FEET OF

- 11 (C) FOR A SIMPLE PUMPING STATION AND FORCE MAIN, \$2,000.00.
- 12 (D) FOR A SMALL DIAMETER PRESSURE SEWER AND GRINDER PUMPING
- 13 STATION CONSISTING OF NOT MORE THAN 2,000 FEET OF SEWER LINE AND
- 14 NOT MORE THAN 10 GRINDER PUMPING STATIONS, \$2,000.00.
- 15 (E) FOR SMALL DIAMETER PRESSURE SEWER AND GRINDER PUMPING
- 16 STATION PROJECTS NOT COVERED BY SUBDIVISION (D) AND NOT MORE THAN
- 17 5,000 FEET OF SEWER LINE AND NOT MORE THAN 25 GRINDER PUMPING
- 18 STATIONS, \$4,000.00.
- 19 (6) EXCEPT AS PROVIDED IN SUBSECTION (8), IF AN APPLICANT DOES
- 20 NOT COMPLY WITH SUBSECTION (4), THE DEPARTMENT SHALL NOT CONDUCT AN

- 2 (A) UNTIL SEPTEMBER 30, 2008, A PERMIT DECISION SHALL BE MADE
- 3 WITHIN 20 BUSINESS DAYS OF RECEIPT BY THE DEPARTMENT OF THE
- 4 COMPLETE APPLICATION.
- 5 (B) FROM OCTOBER 1, 2008 THROUGH SEPTEMBER 30, 2009, A PERMIT
- 6 DECISION SHALL BE MADE WITHIN 15 BUSINESS DAYS OF RECEIPT BY THE
- 7 DEPARTMENT OF THE COMPLETE APPLICATION.
- 8 (C) FROM OCTOBER 1, 2009 THROUGH SEPTEMBER 30, 2010, A PERMIT
- 9 DECISION SHALL BE MADE WITHIN 10 BUSINESS DAYS OF RECEIPT BY THE
- 10 DEPARTMENT OF THE COMPLETE APPLICATION.
- 11 (10) IF THE DEPARTMENT FAILS TO MEET THE DEADLINES SPECIFIED
- 12 IN SUBSECTION (9), THE DEPARTMENT SHALL CONTINUE TO EXPEDITE THE
- 13 APPLICATION REVIEW PROCESS FOR AN APPLICATION SUBMITTED UNDER THIS
- 14 SECTION. HOWEVER, THE FEE FOR AN EXPEDITED REVIEW REQUIRED UNDER
- 15 THIS SECTION SHALL BE REFUNDED IF THE DEPARTMENT FAILS TO MEET THE
