A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 199 (MCL 750.199).

- 8 (2) A PERSON WHO KNOWINGLY OR WILLFULLY CONCEALS OR HARBORS
- 9 FOR THE PURPOSE OF CONCEALMENT FROM A PEACE OFFICER A PERSON WHO IS
