

HOUSE BILL No. 5090

August 10, 2005, Introduced by Rep. Lemmons, III and referred to the Committee on Banking and Financial Services.

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending sections 82103, 82105, 82106, and 82116 (MCL 324.82103, 324.82105, 324.82106, and 324.82116), sections 82103 and 82116 as added by 1995 PA 58, section 82105 as amended by 1998 PA 297, and section 82106 as amended by 2004 PA 587, and by adding sections 82103a, 82103b, 82103c, 82103d, 82103e, 82103f, 82103g, 82103h, 82103i, 82103j, 82103k, 82103l, and 82116a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 82103. (1) Except as otherwise provided, a snowmobile
2 shall not be operated unless the owner first **MAKES APPLICATION FOR**
3 **A CERTIFICATE OF TITLE AND** obtains a certificate of registration
4 and a registration decal. The **APPLICATION FOR A CERTIFICATE OF**

1 **TITLE SHALL BE MADE AND A** certificate of registration shall be
2 secured at the time of purchase or transfer of ownership. A
3 certificate of registration or a registration decal is not required
4 for a snowmobile operated exclusively on lands owned or under the
5 control of the snowmobile owner or for a snowmobile used entirely
6 in a safety education and training program conducted by a certified
7 snowmobile safety instructor and authorized ~~pursuant to~~ **UNDER**
8 **section 82108 OR FOR A SNOWMOBILE REGISTERED IN ANOTHER STATE AND**
9 **USED TEMPORARILY IN THIS STATE FOR NOT MORE THAN 60 DAYS.**

10 (2) A person who ~~is convicted of a violation of~~ **VIOLATES**
11 this section ~~shall be fined~~ **IS SUBJECT TO A CIVIL FINE OF** not
12 more than \$50.00 **PLUS COSTS.**

13 **SEC. 82103A. (1) AFTER JULY 1, 2006, EACH SNOWMOBILE SOLD BY A**
14 **DEALER TO A RETAIL PURCHASER IS SUBJECT TO THE CERTIFICATE OF TITLE**
15 **PROVISIONS OF THIS PART.**

16 (2) **AFTER JULY 1, 2006, A PERSON WHO PURCHASES OR OTHERWISE**
17 **ACQUIRES A NEW OR USED SNOWMOBILE SHALL APPLY FOR A CERTIFICATE OF**
18 **TITLE AS PROVIDED IN THIS PART.**

19 (3) **AFTER JULY 1, 2006, THE OWNER OF A SNOWMOBILE THAT HAS NOT**
20 **BEEN TITLED UNDER SUBSECTION (1) OR (2) MAY APPLY FOR AND, IF**
21 **OTHERWISE ELIGIBLE, RECEIVE A CERTIFICATE OF TITLE ISSUED UNDER**
22 **THIS PART.**

23 **SEC. 82103B. AFTER A SNOWMOBILE HAS BEEN TITLED UNDER THIS**
24 **PART, BOTH OF THE FOLLOWING SHALL OCCUR:**

25 (A) **THE OWNER SHALL NOT SELL OR OTHERWISE ASSIGN OWNERSHIP IN**
26 **THE SNOWMOBILE WITHOUT DELIVERING TO THE TRANSFEREE A CERTIFICATE**
27 **OF TITLE SHOWING ASSIGNMENT OF THE SNOWMOBILE IN THE TRANSFEREE'S**

1 NAME.

2 (B) A PERSON SHALL NOT PURCHASE OR OTHERWISE ACQUIRE A
3 SNOWMOBILE WITHOUT OBTAINING A CERTIFICATE OF TITLE FOR THE
4 SNOWMOBILE IN THE MANNER PROVIDED IN THIS PART.

5 SEC. 82103C. (1) A MANUFACTURER, IMPORTER, DEALER, OR OTHER
6 PERSON SHALL NOT SELL OR OTHERWISE TRANSFER A NEW SNOWMOBILE TO A
7 DEALER, TO BE USED BY THE DEALER FOR PURPOSES OF DISPLAY AND
8 RESALE, WITHOUT DELIVERING TO THE DEALER A MANUFACTURER'S
9 CERTIFICATE OF ORIGIN EXECUTED IN ACCORDANCE WITH THIS SECTION. A
10 DEALER SHALL NOT PURCHASE OR OTHERWISE ACQUIRE A NEW SNOWMOBILE
11 WITHOUT OBTAINING A MANUFACTURER'S CERTIFICATE OF ORIGIN.

12 (2) A MANUFACTURER'S CERTIFICATE OF ORIGIN SHALL CONTAIN THE
13 FOLLOWING INFORMATION:

14 (A) A DESCRIPTION OF THE SNOWMOBILE, INCLUDING YEAR, MAKE,
15 MODEL OR SERIES, AND VEHICLE IDENTIFICATION NUMBER.

16 (B) CERTIFICATION OF THE DATE OF THE SNOWMOBILE'S TRANSFER TO
17 THE DEALER.

18 (C) THE DEALER'S NAME AND ADDRESS.

19 (D) CERTIFICATION THAT THIS TRANSACTION IS THE FIRST TRANSFER
20 OF THE NEW SNOWMOBILE IN ORDINARY COMMERCE.

21 (E) THE TRANSFEROR'S SIGNATURE AND ADDRESS.

22 (3) AN ASSIGNMENT OF A MANUFACTURER'S CERTIFICATE OF ORIGIN
23 SHALL BE PRINTED ON THE CERTIFICATE. THE ASSIGNMENT SHALL INCLUDE
24 THE NAME AND ADDRESS OF THE TRANSFEREE, A CERTIFICATION THAT THE
25 SNOWMOBILE IS NEW, AND A WARRANTY THAT THE TRANSFEROR'S OWNERSHIP
26 RIGHTS AT THE TIME OF DELIVERY ARE SUBJECT ONLY TO THE SECURED
27 INTERESTS SET FORTH IN THE ASSIGNMENT.

1 SEC. 82103D. AN APPLICATION FOR A SNOWMOBILE CERTIFICATE OF
2 TITLE SHALL BE AS PRESCRIBED BY THE DEPARTMENT OF STATE AND
3 ACCOMPANIED BY THE REQUIRED FEES. THE APPLICATION SHALL BE
4 CERTIFIED BY THE OWNER OR PURCHASER AND SHALL CONTAIN, IN ADDITION
5 TO OTHER INFORMATION REQUIRED BY THE DEPARTMENT OF STATE, THE
6 FOLLOWING INFORMATION:

7 (A) THE APPLICANT'S NAME AND BONA FIDE RESIDENCE ADDRESS OF
8 THE OWNER OR BUSINESS ADDRESS OF A FIRM, ASSOCIATION, OR
9 CORPORATION.

10 (B) A STATEMENT OF ANY SECURITY INTEREST OR OTHER LIENS ON THE
11 SNOWMOBILE, ALONG WITH THE NAME AND ADDRESS OF ANY LIENHOLDER.

12 (C) IF A LIEN IS NOT OUTSTANDING, A STATEMENT OF THAT FACT.

13 (D) A DESCRIPTION OF THE SNOWMOBILE, INCLUDING THE YEAR, MAKE,
14 MODEL OR SERIES, AND VEHICLE IDENTIFICATION NUMBER.

15 SEC. 82103E. (1) EXCEPT AS PROVIDED IN SUBSECTION (2), THE
16 PURCHASER OR TRANSFEREE OF A SNOWMOBILE, WITHIN 15 DAYS AFTER THE
17 DATE OF PURCHASE OR TRANSFER, SHALL APPLY TO THE DEPARTMENT OF
18 STATE FOR ISSUANCE OF A CERTIFICATE OF TITLE FOR THE SNOWMOBILE.

19 (2) A DEALER SELLING SNOWMOBILES AT RETAIL, WITHIN 15 DAYS
20 AFTER DELIVERING A SNOWMOBILE TO A RETAIL PURCHASER, SHALL APPLY
21 FOR ISSUANCE OF A SNOWMOBILE CERTIFICATE OF TITLE IN THE
22 PURCHASER'S NAME. THE PURCHASER OF THE SNOWMOBILE SHALL SIGN THE
23 APPLICATION AND OTHER PAPERS NECESSARY TO ENABLE THE DEALER TO
24 SECURE THE TITLE FROM THE DEPARTMENT OF STATE. IF THE SNOWMOBILE
25 WAS MANUFACTURED AFTER JULY 1, 2006, AND WAS NOT PREVIOUSLY TITLED,
26 THE APPLICATION SHALL BE ACCOMPANIED BY A MANUFACTURER'S
27 CERTIFICATE OF ORIGIN.

1 (3) AT THE REQUEST OF AN APPLICANT, THE DEPARTMENT OF STATE
2 SHALL PROCESS AN APPLICATION FOR A SNOWMOBILE CERTIFICATE OF TITLE
3 ON AN EXPEDITED BASIS. THE DEPARTMENT OF STATE MAY CHOOSE ANY
4 METHOD TO EXPEDITE A CERTIFICATE OF TITLE.

5 (4) AN APPLICATION FILED WITH THE DEPARTMENT OF STATE UNDER
6 THIS SECTION SHALL BE ACCOMPANIED BY THE FEE OR FEES PRESCRIBED IN
7 SECTION 82103F.

8 (5) BEGINNING JULY 1, 2006, A PERSON WHO VIOLATES THIS SECTION
9 IS SUBJECT TO A CIVIL FINE OF NOT MORE THAN \$100.00 PLUS COSTS.

10 SEC. 82103F. (1) THE DEPARTMENT OF STATE SHALL CHARGE A FEE OF
11 \$15.00 FOR PROCESSING AN APPLICATION FOR A SNOWMOBILE CERTIFICATE
12 OF TITLE OR A DUPLICATE SNOWMOBILE CERTIFICATE OF TITLE. THE
13 DEPARTMENT OF STATE SHALL CHARGE ADDITIONAL FEES FOR A SNOWMOBILE
14 CERTIFICATE OF TITLE AS FOLLOWS:

15 (A) FOR PROCESSING AN APPLICATION ON AN EXPEDITED BASIS UPON
16 THE REQUEST OF THE TRANSFEROR OR TRANSFEREE OR ANYONE WHO SEEKS AN
17 EXPEDITED TITLE TRANSACTION FOR THE TRANSFEROR OR TRANSFEREE, A
18 CHARGE OF \$5.00 PLUS ANY EXPEDITED MAILING OR DELIVERY COSTS.

19 (B) IF AN APPLICATION FOR A SNOWMOBILE CERTIFICATE OF TITLE IS
20 NOT MADE AND THE FEE PAID WITHIN 15 DAYS AS PROVIDED IN SECTION
21 82103E, A TRANSFER OF THE SNOWMOBILE'S OWNERSHIP MAY BE EFFECTED
22 AND A VALID CERTIFICATE OF TITLE ISSUED BY THE DEPARTMENT OF STATE
23 ONLY UPON PAYMENT OF A LATE TRANSFER FEE OF \$15.00.

24 (2) THE DEPARTMENT OF STATE SHALL CHARGE A FEE OF \$22.00 FOR
25 PROCESSING AN APPLICATION FOR A SNOWMOBILE REGISTRATION UNDER
26 SECTION 82105.

27 (3) THE DEPARTMENT OF STATE SHALL CHARGE A FEE OF \$10.00 FOR A

1 VEHICLE NUMBER REPLACED ON OR ASSIGNED TO A SNOWMOBILE BY THE
2 DEPARTMENT OF STATE UNDER SECTION 82116A.

3 (4) IF A CHECK OR DRAFT IN PAYMENT OF A REQUIRED FEE IS NOT
4 PAID ON ITS FIRST PRESENTATION, THE FEE IS DELINQUENT AS OF THE
5 DATE THE CHECK OR DRAFT WAS TENDERED. THE PERSON TENDERING THE
6 CHECK OR DRAFT REMAINS LIABLE FOR THE PAYMENT OF EACH FEE AND ANY
7 PENALTY.

8 (5) THE DEPARTMENT OF STATE MAY SUSPEND THE OPERATOR'S OR
9 CHAUFFEUR'S LICENSE ISSUED UNDER THE MICHIGAN VEHICLE CODE, 1949 PA
10 300, MCL 257.1 TO 257.923, OF THE PERSON TENDERING THE CHECK OR
11 DRAFT FOR A SNOWMOBILE CERTIFICATE OF TITLE OR ITS REGISTRATION IF
12 THE DEPARTMENT OF STATE HAS DETERMINED THAT A FEE PRESCRIBED IN
13 THIS SECTION HAS NOT BEEN PAID AND REMAINS UNPAID AFTER REASONABLE
14 NOTICE OR DEMAND.

15 (6) IF A FEE IS STILL DELINQUENT 15 DAYS AFTER THE DEPARTMENT
16 OF STATE HAS GIVEN NOTICE TO A PERSON WHO TENDERED THE CHECK OR
17 DRAFT, A \$25.00 PENALTY SHALL BE ASSESSED AND COLLECTED IN ADDITION
18 TO THE FEE.

19 (7) EXCEPT AS OTHERWISE PROVIDED IN THIS PART, THE TITLE FEES
20 AND PENALTIES COLLECTED UNDER THIS SECTION SHALL BE DEPOSITED IN
21 THE GENERAL FUND AND USED FIRST TO DEFRAY THE ADMINISTRATIVE COSTS
22 OF THE DEPARTMENT OF STATE REQUIRED BY THE TITLE PROVISIONS OF THIS
23 PART. ANY MONEY NOT REQUIRED FOR ADMINISTRATION OF THE TITLE
24 PROVISIONS OF THIS PART SHALL BE CREDITED EACH YEAR TO THE
25 RECREATIONAL SNOWMOBILE TRAIL IMPROVEMENT FUND.

26 SEC. 82103G. (1) THE DEPARTMENT OF STATE MAY REFUSE TO ISSUE A
27 SNOWMOBILE CERTIFICATE OF TITLE IF ANY OF THE FOLLOWING OCCUR:

1 (A) THE APPLICANT HAS FAILED TO FURNISH ALL REQUIRED
2 INFORMATION OR REASONABLE ADDITIONAL INFORMATION REQUESTED BY THE
3 DEPARTMENT OF STATE.

4 (B) THE REQUIRED FEES HAVE NOT BEEN PAID.

5 (C) THE APPLICANT IS NOT ENTITLED TO A SNOWMOBILE CERTIFICATE
6 OF TITLE UNDER THIS PART.

7 (D) THE APPLICATION CONTAINS A FALSE OR FRAUDULENT STATEMENT.

8 (E) THE DEPARTMENT OF STATE HAS REASONABLE GROUNDS TO BELIEVE
9 THAT THE SNOWMOBILE WAS STOLEN OR EMBEZZLED.

10 (2) IF SATISFIED THAT THE APPLICANT IS THE OWNER OF THE
11 SNOWMOBILE AND IS OTHERWISE ENTITLED TO A SNOWMOBILE CERTIFICATE OF
12 TITLE, THE DEPARTMENT OF STATE SHALL ISSUE A SNOWMOBILE CERTIFICATE
13 OF TITLE IN THE APPLICANT'S NAME. THE CERTIFICATE SHALL BE MAILED
14 OR OTHERWISE DELIVERED TO THE OWNER OF THE SNOWMOBILE OR TO ANOTHER
15 PERSON SPECIFIED BY THE OWNER IN A SEPARATE INSTRUMENT THAT IS IN A
16 FORM PRESCRIBED BY THE DEPARTMENT OF STATE.

17 (3) IF THE DEPARTMENT OF STATE IS NOT SATISFIED AS TO THE
18 OWNERSHIP OF A SNOWMOBILE THAT IS LESS THAN 6 YEARS OLD AND WHOSE
19 VALUE IS OVER \$2,500.00, BEFORE TITLING THE SNOWMOBILE AND ISSUING
20 A CERTIFICATE OF TITLE, THE DEPARTMENT OF STATE MAY REQUIRE THE
21 APPLICANT TO FILE A PROPERLY EXECUTED SURETY BOND IN A FORM
22 PRESCRIBED BY THE DEPARTMENT OF STATE AND EXECUTED BY THE APPLICANT
23 AND A COMPANY AUTHORIZED TO CONDUCT A SURETY BUSINESS IN THIS
24 STATE. THE BOND SHALL BE IN AN AMOUNT EQUAL TO TWICE THE VALUE OF
25 THE SNOWMOBILE AS DETERMINED BY THE DEPARTMENT OF STATE AND SHALL
26 BE CONDITIONED TO INDEMNIFY OR REIMBURSE THE DEPARTMENT OF STATE,
27 ANY PRIOR OWNER, AND ANY SUBSEQUENT PURCHASER OF THE SNOWMOBILE AND

1 THEIR SUCCESSORS IN INTEREST AGAINST ANY EXPENSE, LOSS, OR DAMAGE,
2 INCLUDING REASONABLE ATTORNEY FEES, BY REASON OF THE ISSUANCE OF A
3 CERTIFICATE OF TITLE TO THE SNOWMOBILE OR ON ACCOUNT OF ANY DEFECT
4 IN THE RIGHT, TITLE, OR INTEREST OF THE APPLICANT IN THE
5 SNOWMOBILE. AN INTERESTED PERSON HAS A RIGHT OF ACTION TO RECOVER
6 ON THE BOND FOR A BREACH OF THE CONDITIONS OF THE BOND, BUT THE
7 AGGREGATE LIABILITY OF THE SURETY TO ALL PERSONS SHALL NOT EXCEED
8 THE AMOUNT OF THE BOND. THE BOND SHALL BE RETURNED AT THE END OF 3
9 YEARS, OR BEFORE 3 YEARS IF THE SNOWMOBILE IS NO LONGER TITLED IN
10 THIS STATE AND THE CURRENTLY VALID CERTIFICATE OF TITLE IS
11 SURRENDERED TO THE DEPARTMENT OF STATE, UNLESS THE DEPARTMENT OF
12 STATE HAS RECEIVED NOTIFICATION OF THE PENDENCY OF AN ACTION TO
13 RECOVER ON THE BOND.

14 (4) IF THE DEPARTMENT OF STATE IS NOT SATISFIED AS TO THE
15 OWNERSHIP OF A SNOWMOBILE THAT IS AT LEAST 6 YEARS OLD AND WHOSE
16 VALUE DOES NOT EXCEED \$2,500.00, THE DEPARTMENT OF STATE SHALL
17 REQUIRE THE APPLICANT TO CERTIFY THAT THE APPLICANT IS THE OWNER OF
18 THE SNOWMOBILE AND ENTITLED TO TITLE THE SNOWMOBILE.

19 SEC. 82103H. (1) A SNOWMOBILE CERTIFICATE OF TITLE SHALL BE
20 MANUFACTURED IN A MANNER TO PROHIBIT AS NEARLY AS POSSIBLE THE
21 ABILITY TO REPRODUCE, ALTER, COUNTERFEIT, FORGE, OR DUPLICATE THE
22 CERTIFICATE WITHOUT READY DETECTION AND SHALL CONTAIN ON ITS FACE
23 THE INFORMATION SET FORTH IN THE APPLICATION, INCLUDING A NOTATION
24 OF ALL SECURED INTERESTS IN THE SNOWMOBILE; THE DATE ON WHICH THE
25 APPLICATION WAS FILED; AND OTHER INFORMATION REQUIRED BY THE
26 DEPARTMENT OF STATE.

27 (2) THE DEPARTMENT OF STATE SHALL PRESCRIBE A UNIFORM METHOD

1 OF NUMBERING SNOWMOBILE CERTIFICATES OF TITLE.

2 (3) A SNOWMOBILE CERTIFICATE OF TITLE SHALL CONTAIN A FORM FOR
3 ASSIGNMENT AND WARRANTY OF TITLE BY THE OWNER WITH SPACE FOR THE
4 NOTATION OF A SECURITY INTEREST IN THE SNOWMOBILE. THE SNOWMOBILE
5 CERTIFICATE OF TITLE MAY ALSO CONTAIN OTHER FORMS THAT THE
6 DEPARTMENT OF STATE CONSIDERS NECESSARY TO FACILITATE THE EFFECTIVE
7 ADMINISTRATION OF THIS PART. THE CERTIFICATE SHALL BEAR THE COAT OF
8 ARMS OF THIS STATE.

9 (4) A PERSON WHO INTENTIONALLY REPRODUCES, ALTERS,
10 COUNTERFEITS, FORGES, OR DUPLICATES A SNOWMOBILE CERTIFICATE OF
11 TITLE OR WHO USES A REPRODUCED, ALTERED, COUNTERFEITED, FORGED, OR
12 DUPLICATED SNOWMOBILE CERTIFICATE OF TITLE IS SUBJECT TO THE
13 FOLLOWING PENALTIES:

14 (A) IF THE INTENT OF REPRODUCTION, ALTERATION, COUNTERFEITING,
15 FORGING, DUPLICATION, OR USE WAS TO COMMIT OR AID IN THE COMMISSION
16 OF AN OFFENSE PUNISHABLE BY IMPRISONMENT FOR MORE THAN 1 YEAR, THE
17 PERSON COMMITTING THE REPRODUCTION, ALTERATION, COUNTERFEITING,
18 FORGING, DUPLICATION, OR USE IS GUILTY OF A FELONY, PUNISHABLE BY
19 IMPRISONMENT FOR A PERIOD EQUAL TO THAT WHICH COULD BE IMPOSED FOR
20 THE COMMISSION OF THE OFFENSE THE PERSON HAD THE INTENT TO AID OR
21 COMMIT. THE COURT MAY ALSO ASSESS A FINE OF NOT MORE THAN \$5,000.00
22 AGAINST THE PERSON.

23 (B) IF THE INTENT OF THE REPRODUCTION, ALTERATION,
24 COUNTERFEITING, FORGING, DUPLICATION, OR USE WAS TO COMMIT OR AID
25 IN THE COMMISSION OF AN OFFENSE PUNISHABLE BY IMPRISONMENT FOR NOT
26 MORE THAN 1 YEAR, THE PERSON COMMITTING THE REPRODUCTION,
27 ALTERATION, COUNTERFEITING, FORGING, DUPLICATION, OR USE IS GUILTY

1 OF A MISDEMEANOR, PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 1
2 YEAR, OR A FINE OF NOT MORE THAN \$1,000.00, OR BOTH.

3 SEC. 82103I. (1) IF THE TRANSFER OF OWNERSHIP OF A SNOWMOBILE
4 IS BY OPERATION OF LAW, SUCH AS UPON INHERITANCE, DEVISE, BEQUEST,
5 ORDER IN BANKRUPTCY, INSOLVENCY, REPLEVIN, OR EXECUTION OF SALE, IF
6 A SNOWMOBILE IS SOLD TO SATISFY A STORAGE OR REPAIR CHARGE, OR IF
7 REPOSSESSION IS HAD UPON DEFAULT IN PERFORMANCE OF THE TERMS OF A
8 SECURITY AGREEMENT, UPON THE SURRENDER OF THE PRIOR CERTIFICATE OF
9 TITLE OR THE MANUFACTURER'S OR IMPORTER'S CERTIFICATE, OR, IF THAT
10 IS NOT POSSIBLE, UPON PRESENTATION OF SATISFACTORY PROOF TO THE
11 DEPARTMENT OF STATE OF OWNERSHIP AND A RIGHT OF POSSESSION TO THE
12 SNOWMOBILE, AND UPON PAYMENT OF THE FEES PRESCRIBED IN SECTION
13 82103F AND PRESENTATION OF AN APPLICATION FOR A CERTIFICATE OF
14 TITLE, THE DEPARTMENT OF STATE MAY ISSUE TO THE APPLICANT A
15 CERTIFICATE OF TITLE TO THE SNOWMOBILE. A CERTIFICATION BY THE
16 PERSON OR AGENT OF THE PERSON TO WHOM POSSESSION OF THE SNOWMOBILE
17 PASSED, SETTING FORTH THE FACTS ENTITLING THE PERSON TO POSSESSION
18 AND OWNERSHIP, TOGETHER WITH A COPY OF THE JOURNAL ENTRY, COURT
19 ORDER, OR INSTRUMENT UPON WHICH THE CLAIM OF POSSESSION AND
20 OWNERSHIP IS FOUNDED, IS SATISFACTORY PROOF OF OWNERSHIP AND RIGHT
21 OF POSSESSION. IF THE APPLICANT CANNOT PRODUCE PROOF OF OWNERSHIP,
22 THE APPLICANT MAY APPLY TO THE DEPARTMENT OF STATE AND SUBMIT
23 EVIDENCE THE APPLICANT HAS, AND THE DEPARTMENT OF STATE, IF THE
24 DEPARTMENT FINDS THE EVIDENCE SUFFICIENT, MAY THEN ISSUE A
