HOUSE SUBSTITUTE FOR SENATE BILL NO. 1618

A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961,"

by amending section 181 (MCL 600.181), as added by 2003 PA 97.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 181. (1) The justice system fund is created in the state
 treasury. The money in the fund shall be used as provided in this
 section.

4 (2) The state treasurer shall credit to the justice system
5 fund deposits of proceeds from the collection of revenue from court
6 assessments and costs designated by law for deposit in the fund and
7 shall credit all income from investment credited to the fund by the
8 state treasurer. The state treasurer may invest money in the fund
9 in any manner authorized by law for the investment of state money.
10 However, an investment shall not interfere with any apportionment,

allocation, or payment of money as required by this section. The
 unencumbered balance remaining in the fund at the end of a fiscal
 year shall remain in the fund and shall not revert to the general
 fund.
