A SCHOOL DISTRICT'S STUDY AND REPORT SHALL ADDRESS POSSIBILITIES FOR SHARING OF AT LEAST ALL OF THE FOLLOWING 4 5 NONINSTRUCTIONAL SERVICES: 6 (A) PUPIL TRANSPORTATION FOR ALL CLASSES OF PUPILS AND ALL 7 TYPES OF PROGRAMS. (B) HUMAN RESOURCES ADMINISTRATION. 8 9 (C) PROCUREMENT OF SUPPLIES AND OTHER PURCHASING. 10 (D) TECHNOLOGY SUPPORT SERVICES, INCLUDING, BUT NOT LIMITED 11 TO, INFORMATION TECHNOLOGY. 12 (E) PROFESSIONAL DEVELOPMENT. 13 (F) ACCOUNTING AND OTHER FINANCIAL SERVICES. (G) LEGAL SERVICES. 14 15 (H) FOOD AND CHILD NUTRITIONAL SERVICES. 16 (I) EVENT MANAGEMENT. 17 (J) PRODUCTION PRINTING AND GRAPHICS. 18 (K) SHIPPING AND RECEIVING SERVICES.  SUMMARY REPORT ON SERVICE SHARING TO THE DEPARTMENT IN THE FORM AND
 MANNER PRESCRIBED BY THE DEPARTMENT. NOT LATER THAN 2 MONTHS AFTER
 RECEIVING THE REPORTS FROM INTERMEDIATE SCHOOL DISTRICTS, THE
 DEPARTMENT SHALL COMPILE THIS INFORMATION AND SUBMIT A SUMMARY TO
 THE STANDING COMMITTEES OF THE LEGISLATURE HAVING RESPONSIBILITY
 FOR EDUCATION LEGISLATION.
