## SUBSTITUTE FOR HOUSE BILL NO. 4896

A bill to amend 1978 PA 368, entitled "Public health code,"

by amending section 2882 (MCL 333.2882), as amended by 2002 PA 691.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 Sec. 2882. (1) Except as otherwise provided in section 2890,
- 2 upon written request and payment of the prescribed fee, the state
- 3 registrar or local registrar shall issue the appropriate 1 of the
- 4 following:
- 5 (a) A certified copy of a live birth record, an affidavit of
- 6 parentage filed after June 1, 1997, or a record of stillbirth filed
- 7 after June 1, 2003 to 1 of the following:
- 8 (i) The individual who is the subject of the record.
- 9 (ii) A parent named in the record.

- 1 (iii) An heir, a legal representative, or a legal guardian of
- 2 the individual who is the subject of the record.
- 3 (iv) A court of competent jurisdiction.
- 4 (b) If the live birth record is 100 or more years old, a
- 5 certified copy of the live birth record to any applicant.
- 6 (c) A certified copy of a death record, including the cause of
- 7 death, to any applicant.
- 8 (d) A certified copy of a marriage or divorce record to any
- 9 applicant, except as provided by rule.
- 10 (e) A certified copy of a fetal death record that was filed
- 11 before September 30, 1978, to any applicant.
- 12 (2) Upon written request of an adult who has been adopted and
- 13 payment of the prescribed fee, the state registrar shall issue to
- 14 that individual a copy of his or her original certificate of live
- 15 birth, if the written request identifies the name of the adult
- 16 adoptee and is accompanied by a copy of a central adoption registry
- 17 clearance reply form that was completed by the family independence
- 18 agency DEPARTMENT OF HUMAN SERVICES and delivered to that
- 19 individual as required by section  $\frac{68(9)}{68(8)}$  of the Michigan
- 20 adoption code, chapter X of the probate code of 1939, 1939 PA 288,
- 21 MCL 710.68.
- 22 (3) Upon written request of a confidential intermediary
- 23 appointed under section 68b of the Michigan adoption code, chapter
- 24 X of the probate code of 1939, 1939 PA 288, MCL 710.68b,
- 25 presentation of a certified copy of the order of appointment,
- 26 identification of the name of the adult adoptee, and payment of the
- 27 required fee, the state registrar shall issue to the confidential

- 1 intermediary a copy of the original certificate of live birth of
- 2 the adult adoptee on whose behalf the intermediary was appointed.
- 3 (4) A copy of the original certificate of live birth provided
- 4 under subsection (2) or (3) shall have the following phrase marked
- 5 on the face of the copy: "This document is a copy of a sealed
- 6 record and is not the active birth certificate of the individual
- 7 whose name appears on this document".
- 8 Enacting section 1. This amendatory act does not take effect
- 9 unless House Bill No. 6287 of the 94th Legislature is enacted into
