## **HOUSE BILL No. 6037**

(As amended December 3, 2008)

May 1, 2008, Introduced by Reps. Condino, Sak, Farrah, Virgil Smith, Shaffer, Wojno, Hammon, Knollenberg, Accavitti, Amos, Pavlov, Green, Meadows, Dean and Cushingberry and referred to the Committee on Regulatory Reform.

A bill to amend 1931 PA 328, entitled "The Michigan penal code,"

(MCL 750.1 to 750.568) by adding section 180a.

## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

- 1 SEC. 180A. (1) SUBJECT TO SUBSECTION (2), A PERSON SHALL NOT
- 2 VIOLATE, OR CONSPIRE WITH 1 OR MORE PERSONS TO VIOLATE, SECTION 16,
- 3 16A, OR 16B OF THE CEMETERY REGULATION ACT, 1968 PA 251, MCL
- 4 456.536, 456.536A, AND 456.536B, OR SECTION 12 OF THE PREPAID
- 5 FUNERAL AND CEMETERY SALES ACT, 1986 PA 255, MCL 328.222. A PERSON
- WHO VIOLATES THIS SUBSECTION IS GUILTY OF A CRIME AS FOLLOWS:
  - (A) FOR A FIRST VIOLATION, THE PERSON IS GUILTY OF A

- MISDEMEANOR PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN [93] DAYS OR
- A FINE OF NOT MORE THAN \$10,000.00 OR UP TO TRIPLE THE AMOUNT OF
- 10 THE LOSS, THEFT, OR EMBEZZLEMENT, WHICHEVER IS LARGER, OR BOTH. THE

- 1 COURT MAY ALSO ORDER RESTITUTION.
- 2 (B) FOR A SECOND OR SUBSEQUENT VIOLATION, THE PERSON IS GUILTY
- 3 OF A FELONY PUNISHABLE BY IMPRISONMENT FOR NOT MORE THAN 10 YEARS
- 4 OR A FINE OF NOT MORE THAN \$50,000.00 OR UP TO TRIPLE THE AMOUNT OF
- 5 THE LOSS, THEFT, OR EMBEZZLEMENT, WHICHEVER IS LARGER, OR BOTH. THE
- 6 COURT MAY ALSO ORDER RESTITUTION.
- 7 (2) THIS SECTION DOES NOT PROHIBIT A PERSON FROM BEING CHARGED
- 8 AND CONVICTED OF ANY OTHER VIOLATION COMMITTED BY THAT PERSON
- 9 DURING THE COURSE OF THE VIOLATION OF SUBSECTION (1).
- 10 (3) AS USED IN THIS SECTION:
- 11 (A) "CEMETERY ENTITY" MEANS A CORPORATION, LIMITED LIABILITY
- 12 COMPANY, OR OTHER LEGAL ENTITY THAT OWNS, MANAGES, OR OPERATES A
- 13 CEMETERY AND INCLUDES AN INDIVIDUAL WHO OWNS, MANAGES, OR OPERATES
- 14 A CEMETERY.
- 15 (B) "CONTROLLING INTEREST" MEANS THE CAPABILITY TO DECIDE THE
- 16 OPERATING AND FINANCIAL POLICIES OF A CEMETERY ENTITY OR TO SELECT
- 17 THE OFFICERS OR DIRECTORS WITH MAJORITY CONTROL OF THE CEMETERY
- 18 ENTITY.
- 19 (C) "PERSON" MEANS AN INDIVIDUAL, GROUP OF INDIVIDUALS, SOLE
- 20 PROPRIETORSHIP, PARTNERSHIP, LIMITED LIABILITY COMPANY,
- 21 ASSOCIATION, CORPORATION, CEMETERY, CEMETERY ENTITY, OR ANY
- 22 COMBINATION OF THOSE LEGAL ENTITIES. PERSON INCLUDES AN INDIVIDUAL
- 23 WHO IS AN OFFICER, DIRECTOR, OR MEMBER, ENGAGED IN A MANAGEMENT
- 24 ROLE, OR WHO HAS A CONTROLLING INTEREST IN A CEMETERY OR CEMETERY
- 25 ENTITY.
