- Sec. 1. This act shall be known and may be cited as the
 "children's miracle network fund act".
- 3 Sec. 3. As used in this act:
 - (a) "Department" means the department of community health.
 - (b) "Fund" means the children's miracle network fund created in section 5.
 - Sec. 5. (1) The children's miracle network fund is created in the department to provide funds for donation to the children's miracle network to support the children's miracle network hospitals located in this state in providing life-saving pediatric care,
