SUBSTITUTE FOR

HOUSE BILL NO. 6200

A bill to amend 1980 PA 299, entitled "Occupational code,"

(MCL 339.101 to 339.2919) by adding section 1807a.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 1807A. (1) A PERSON ENGAGED IN THE PRACTICE OF FUNERAL DIRECTING SHALL MAKE A DETERMINATION OF WHETHER A DECEASED PERSON, 2 3 WHOSE REMAINS HAVE BEEN SUBMITTED TO A FUNERAL ESTABLISHMENT FOR 4 FINAL DISPOSITION BY CREMATION, IS A VETERAN OF THE ARMED SERVICES. THE DETERMINATION SHALL BE MADE AT, OR SHORTLY AFTER, THE TIME THE 5 6 ORDER OF DISPOSITION FOR CREMATION IS SIGNED. THE FUNERAL DIRECTOR 7 SHALL DIRECT THE INQUIRY TO THE PERSON WITH AUTHORITY OVER THE 8 DISPOSAL OF THE REMAINS OF THE DECEDENT AND SHALL CONTACT THE 9 NATIONAL CEMETERY ADMINISTRATION'S CENTRAL SCHEDULING OFFICE IN ST. 10 LOUIS, MISSOURI. IF THERE IS ANY DOUBT OF THE PERSON'S STATUS AS A

VETERAN, THE FUNERAL DIRECTOR, IF THERE IS NO PERSON WITH AUTHORITY 1 2 OVER THE DISPOSAL OF THE REMAINS OF THE DECEDENT, OR THE PERSON 3 WITH AUTHORITY OVER THE DISPOSAL OF THE REMAINS OF THE DECEDENT 4 SHALL NOTIFY IN WRITING THE NEAREST STATE OR NATIONAL VETERANS 5 CEMETERY AND THE NATIONAL CEMETERY ADMINISTRATION'S CENTRAL 6 SCHEDULING OFFICE IN ST. LOUIS, MISSOURI. IF THE DECEASED IS DETERMINED, IN ANY MANNER, TO BE A VETERAN OF THE ARMED SERVICES, 7 THE FUNERAL DIRECTOR SHALL GIVE NOTICE TO THE PERSON WITH AUTHORITY 8 9 OVER THE DISPOSAL OF THE REMAINS OF THE DECEDENT AS TO THAT STATUS 10 AND ADVISE THAT PERSON THAT THE VETERAN AND HIS OR HER SPOUSE MAY 11 BE ELIGIBLE TO BE INTERRED AT AN APPROPRIATE VETERANS CEMETERY.

12 (2) IF THE REMAINS OF A VETERAN ARE NOT CLAIMED BY A PERSON 13 WITH AUTHORITY OVER THE DISPOSAL OF THE REMAINS OF THE DECEDENT, 14 THE FUNERAL DIRECTOR SHALL HOLD ANY CREMATED REMAINS FOR AT LEAST 6 15 MONTHS. AT THE EXPIRATION OF 6 MONTHS OR LONGER, THE FUNERAL 16 DIRECTOR SHALL SEND WRITTEN NOTICE TO A PERSON WITH AUTHORITY OVER 17 THE DISPOSAL OF THE REMAINS OF THE DECEDENT REQUESTING DISPOSITION 18 INSTRUCTIONS. IF A WRITTEN RESPONSE TO THE WRITTEN NOTICE IS NOT 19 RECEIVED WITHIN 30 DAYS AFTER THE NOTICE IS SENT, THE FUNERAL 20 DIRECTOR SHALL ATTEMPT TO ARRANGE FOR THE DISPOSITION OF THE 21 REMAINS OF ANY VETERAN AND HIS OR HER SPOUSE IN A STATE OR NATIONAL 22 VETERANS CEMETERY. THE FUNERAL DIRECTOR MAY RELEASE ANY RELEVANT 23 INFORMATION TO THE VETERANS ADMINISTRATION, A VETERANS 24 ORGANIZATION, OR THE NATIONAL CEMETERY ADMINISTRATION'S CENTRAL 25 SCHEDULING OFFICE IN ST. LOUIS, MISSOURI.

26 (3) A FUNERAL DIRECTOR COMPLYING WITH THIS SECTION IS IMMUNE
27 FROM ANY CRIMINAL OR CIVIL LIABILITY REGARDING THE RELEASE OF

(4) AS USED IN THIS SECTION:

(A) "PERSON WITH AUTHORITY OVER THE DISPOSAL OF THE REMAINS OF 5 THE DECEDENT" MEANS THAT PERSON AS DETERMINED UNDER SECTION 3206 OF 6 7 THE ESTATES AND PROTECTED INDIVIDUALS CODE, 1998 PA 386, MCL 8 700.3206.

(B) "VETERANS ORGANIZATION" MEANS AN ASSOCIATION OR OTHER 9 ENTITY ORGANIZED FOR THE BENEFITS OF VETERANS THAT HAS BEEN 10 11 RECOGNIZED OR CHARTERED BY THE UNITED STATES CONGRESS AND INCLUDES, BUT IS NOT LIMITED TO, THE AMERICAN LEGION, THE LEGION OF HONOR, 12 13 THE PATRIOT GUARD, THE MISSING IN AMERICA PROJECT, AND THE VIETNAM VETERANS OF AMERICA. 14
