SUBSTITUTE FOR HOUSE BILL NO. 6341

A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 147b (MCL 750.147b), as added by 1988 PA 371, and by adding section 377d.

THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

Sec. 147b. (1) A person is guilty of ethnic intimidation if 1 that person maliciously, and with specific intent to intimidate or 2 harass another person because of that person's race, color, 3 religion, gender, or national origin, does any of the following: 4 (a) Causes physical contact with another person. 5 6 (b) Damages, destroys, or defaces any real or personal property of another person. (c) Threatens, by word or act, to do an act described in 8 subdivision (a) or (b), if there is reasonable cause to believe 9

- 2 (2) Ethnic intimidation is a felony punishable by imprisonment
- 3 for not more than 2 years, or by a fine of not more than \$5,000.00,

- 19 brought pursuant to this section may recover both of the following:
- 20 (a) Damages in the amount of 3 times the actual damages

- 2 FOLLOWING TO PROPERTY WITHOUT THE EXPRESS PERMISSION OF THE
- 3 PROPERTY OWNER IS CONSIDERED TO HAVE INJURED OR ALTERED THAT
- 4 PROPERTY, WHETHER OR NOT ANY PHYSICAL DAMAGE IS CAUSED:
- 5 (A) HANGS, AFFIXES, OR OTHERWISE PLACES A NOOSE ON THE
- 6 PROPERTY.
- 7 (B) BURNS, OR PLACES WITH INTENT TO BURN, A CROSS OR CROSS-
