## THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 SEC. 1138. (1) IF A PUPIL IS ABSENT FROM SCHOOL FOR UP TO 1

FULL SCHOOL DAY BECAUSE HIS OR HER PARENT[, LEGAL GUARDIAN, OR SIBLING]
IS A
SERVICE MEMBER BEING DEPLOYED ON OR RETURNING FROM ACTIVE DUTY, [OR IF A

PUPIL IS ABSENT FROM SCHOOL FOR UP TO 2 FULL SCHOOL DAYS IF THE LOCATION OF THE DEPLOYMENT OR RETURN IS MORE THAN 300 MILES FROM THE PUPIL'S HOME,] THE

5 SCHOOL OFFICIALS OF A PUBLIC SCHOOL SHALL CONSIDER THAT ABSENCE TO

6 BE AN EXCUSED ABSENCE. THE BOARD OF A SCHOOL DISTRICT OR

7 INTERMEDIATE SCHOOL DISTRICT OR BOARD OF DIRECTORS OF A PUBLIC

8 SCHOOL ACADEMY SHALL ENSURE THAT THEIR ATTENDANCE POLICY IS

(C) "MICHIGAN NATIONAL GUARD" MEANS THAT TERM AS DEFINED IN 10 11 SECTION 105 OF THE MICHIGAN MILITARY ACT, 1967 PA 150, MCL 32.505. (D) "SERVICE MEMBER" MEANS A MEMBER OF THE ARMED FORCES, A 12 13 RESERVE BRANCH OF THE ARMED FORCES, OR THE MICHIGAN NATIONAL GUARD.
