THE PEOPLE OF THE STATE OF MICHIGAN ENACT:

1 Sec. 3. As used in this act:

- (a) "Authorized representative" means either ANY of the following:
- (i) A person empowered by the patient by explicit written authorization to act on the patient's behalf to access, disclose, or consent to the disclosure of the patient's medical record, in accordance with this act.
 - (ii) If the patient is deceased, his ANY OF THE FOLLOWING:
 - (A) HIS or her personal representative. or his
 - (B) HIS or her heirs at law. or the

- 18 possess, preserve, retain, store, or control medical records.
- 19 (h) "Medicaid" means that term as defined in section 2701 of
- 20 the public health code, 1978 PA 368, MCL 333.2701.
- 21 (i) "Medical record" means information oral or recorded in any
- 22 form or medium that pertains to a patient's health care, medical
- 23 history, diagnosis, prognosis, or medical condition and that is
- 24 maintained by a health care provider or health facility in the
- 25 process of CARING FOR the patient's health.
- 26 (j) "Medical records company" means a person who stores,
- 27 locates, or copies medical records for a health care provider or

- 10 (m) "Minor" means an individual who is less than 18 years of
- 11 age, but does not include an individual who is emancipated under
- 12 section 4 of 1968 PA 293, MCL 722.4.
- 13 (n) "Patient" means an individual who receives or has received
- 14 health care from a health care provider or health facility. Patient
- 15 includes a guardian, if appointed, and a parent, guardian, or
- 16 person acting in loco parentis, if the individual is a minor,
- 17 unless the minor lawfully obtained health care without the consent
- 18 or notification of a parent, guardian, or other person acting in
- 19 loco parentis, in which case the minor has the exclusive right to
- 20 exercise the rights of a patient under this act with respect to
- 21 those medical records relating to that care.
- (0) "Person" means an individual, corporation, estate, trust,
- 23 partnership, association, joint venture, government, governmental
- 24 subdivision or agency, or other legal or commercial entity.
